DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This well-built, one and a half story frame house stands atop a knoll, facing south. The house consists of a central (and original) block to which a shed kitchen has been attached to the north (back), a larger shed room to the west, and a shed porch supported by unturned posts to the south. A lean-to shelter was built onto the eastern side. The facade of the original block consists of two bays, a front door centrally located with a double hung sash window to the east. A brick chimney laid in common bond and with a tall narrow base shouldering in at the first story level ascends the east gable end. On either side of it, on both floors, is let a double hung sash window. The A roof is sheathed with tin today, but in earlier times, wood shingles served the purpose. Synthetic tar paper siding, designed to imitate tan bricks, now clad the exterior walls.

The frame is of the post and beam type, with the studs, which were cut by an up and down saw, morticed, tenoned, and pegged into the plates. The studs were incised with Roman numerals, but they were not laid in place sequentially, suggesting that they were probably re-used timbers.

The original block of the house consisted of one room downstairs and one upstairs, to which a box staircase led. The upstairs was unheated.

Behind the house are the remains of the farm yard: the wood pile, water pump, and small sheds and, in the distance, the tobacco barn made of a hewn timber frame.

SPECIFIC DATES First quarter of 19th century. BUILDER/ARCHITECT _____

STATEMENT OF SIGNIFICANCE

This house was probably built as the residence of a small landowner in the last decade of the 18th or first decades of the 19th century. This is indicated by the fact that though it was small, the house was constructed of good materials, carefully put in place, and with interior features, such as the mantelpiece, that show stylistic aspirations and attainment. In addition, had it been a non-landowner's dwelling, it probably would not have had as many (nor as large) glazed windows *on the* double hung sashes, but would have had wooden shutters instead.

In the last quarter of the 19th century, it is known that a black tenant family occupied this dwelling, the family of Robert Ed Coles, whose daughter, Lucy, married Steven Jones, whose house has been recorded as part of this survey. This dwelling is now occupied by a white tenant family, that of J. Wilma Hill. It is not known if the original occupants were white or black, but according to Lucy Coles Jones, who is 91 years old, the house had always been occupied by black families as far back as she had ever heard during her childhood in the 1890's.
