DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Pilkerton House, which faces west, is a 1½ story, 2 bay cabin with lower wings extending from the north and south gables. Although the house was not examined closely, the overall proportions and wall thickness (seen at door jamb) suggest log construction. The building is clad in brick-patterned asphalt. Tarpaper covers the roof of the center section, with corrugated metal on the wings. A single 6/6 window is centered in the west wall of each wing; in the center section, the door (on left) has four large panes, and a sash window pierces the wall to the right.


