DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The present St. Luke M.E. Church stands 20' from the east side of MD. Rte 5 at the corner of Fresh Pond Neck Road in Scotland. The present church was built ca. 1910 and is constructed of weatherboard. It measures 30' across the front facade and is 46' in depth. It rests on a brick and cinder block foundation. There are three cement steps that lead to double wooden doors (hollow). The building is gabled (East-West) and faces west. There is a small cupola atop the west gable it is louvered and topped by a brief tin-covered spire with a spike atop. There is a circular 4paned clear-glass window midway in the west gable. There are two lancet windows 4' clear-glass in the front facade (one on either side of the entrance). There are 4 of these identical lancet windows on the southside of the church and 4 more on the northside. On the north side of the church (attached by a walk-through) is another building which was once used as a church. This structure ca. 1880 is 32' across the front facade and 40' in depth. It is gabled (East-West) and faces west. It has two cement steps that lead to a double wooden doors (hollow). There are 2 6over 6 rectangular 5' clear-glass windows in the front facade. One on either side of the entrance.




