Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Mattingly House stands on the east side of Old Route 5, between the Davis House (SM-371) and the IRS Building (SM-373) in Charlotte Hall, Maryland.

The Mattingly House is a two story, four bay wide gable-roofed house with a double cross gable on the west or entrance facade. A wide one story hipped-roof screened porch extends across the west facade, with entrances on the west, north and south sides.

The entrance doors, one below each of the cross gables, are made of beaded flush paneling. The windows on the north, west, and south facades are mostly 2/2 double hung windows. A six bay wide two bay deep shed roofed wing and an adjoining one story two bay gable roofed wing extend from the east elevation. This section is probably much later than the main block and the windows are mostly paired or triple 6/6 sash. There is a small one story shed-roofed addition on the northeast corner of the house with an entrance on the east facade.

The interior plan is the product of several alterations and is unusual in that circulation along the entire length of the house is only possible on the second floor. There is a stairway at both the north and south ends of the house. Underneath the plaster wall of the south stair there is evidence of hand-split lathing, suggesting that this may be the oldest section of the house. The thick wall separating this section from the gable roofed east addition also suggests a number of different building periods and that the addition was possibly moved there from another location. Another unusual feature of the interior is the cove ceiling of the south room on the second floor. There is little original woodwork or moulding on either floor and most of the walls are covered with thin plywood paneling.

Prepare both a summary paragraph of significance and a general statement of history and support.

The Mattingly House, despite its late nineteenth century appearance, is probably the product of several different building periods, and is undoubtedly the oldest of the three homes once owned by Charlotte Hall School on the east side of Old Route 5 in Charlotte Hall. The use of hand-split lathing in the south stairway and the beaded flush paneling of the two doors are characteristic of the second quarter of the nineteenth century. The thick wall separating the east addition from the rest of the house suggests that the addition was moved from another part of the property and attached to the house. Most of the interior has been greatly altered, however, and most of the mid-century woodwork and moldings no longer exist. The floor plan of the original house has also been obscured.




