Circa 1835-1850

The Martin Welch house is a fairly well-preserved example of a second quarter of the nineteenth century log dwelling house. It is one of the few log houses to survive in the Chaptico District of St. Mary's County. Although very few of the original interior finishes remain, the interior hall-parlor plan and winder stair have survived intact. The mature machine cut nails, the up and down saw marks visible on the studs, and the use of a dovetail notching system suggest a building date between 1835 and 1850.

According to local tradition, this house was built in the 1830s for a Scottish immigrant named Martin Welch. Around the turn of the century, the building served as a school for students in Kindergarten through First grades. At this time, a schoolhouse serving older students was located across the street, next to the Christ Church cemetery.

The Martin Welch house is located south of Zach Fowler Road on the east side of the Chaptico-Hurry Road in the village of Chaptico. This structure is surrounded by a white paling fence. A border of cedar trees lines Chaptico-Hurry Road in front of the house. The house faces west with the principal gable oriented on a north/south axis.

Built sometime between 1835 and 1850, the main block of the Martin Welch house is a one-story, three-bay structure of horizontal log construction with half dovetail notching sheathed with both board and batten and weatherboard siding. The foundation consists of mortared brick and stone piers. The roof was originally sheathed with wood shingles. While these shingles remain in place, they are now covered with a seamed metal roof. The roofline is finished with a boxed cornice. An interior brick chimney pierces the center of the roof's ridgeline. To the south of the main block extends a one-story, one-room addition with a shallow pitch gable roof on the same north/south axis as the main block. This addition is sheathed with asbestos siding and roofed with asphalt shingles. It is supported by a cinderblock pier foundation.

The west (main) elevation is sheathed with board and batten siding. It consists of a central six-light-over-three panel entrance door. The door is flanked on either side by one six-over-six sash window with narrow, molded surrounds. The southern addition is pierced by one six-over-six sash window with narrow, plain surrounds.

The south elevation of the main block is sheathed with weatherboard siding. Where the weatherboard siding has deteriorated, a layer of vertical board siding is visible. Both layers of siding are attached with mature, machine cut nails. The eave of this gable end elevation is pierced by one six-over-six sash window and is finished with a scalloped eave board. The first floor of the main block is partially obscured by the one-story addition which projects to the south. The addition is pierced by one six-over-six sash window with flat, narrow surrounds. An exterior cinderblock chimney stands against the eastern edge of this wing. A shed roof porch extends to the east.

The east elevation of the southern, one-story addition is sheltered by a shed roof porch supported by square posts. This addition is pierced by a four-panel door. Much of the vertical siding covering the main block of the house is missing on this elevation. Here, the hewn logs are clearly visible. Originally chinked with mortar, almost all of this mortar chinking has deteriorated. The main block of the Martin Welch house is pierced by two six-over-six sash windows with narrow, molded surrounds which are on axis with the windows on the west elevation. Two additional six-over-six sash windows, clearly added at a later date, also pierce this elevation. A scalloped

7.1 Description

eave board survives here.

The north elevation is sheathed with weatherboard. The eave is lit by one six-over-six sash window with narrow surrounds. Part of a scalloped eaveboard survives on this elevation.

The interior consists of a hall-parlor plan with an enclosed winder stair. This stair rises from east to west and is separated from the rest of the house by a four-panel door held in place by a metal butterfly hinge. There are no fireplaces on the interior, but a chimney stack rises through the center of the house which once served heating stoves. There are two rooms upstairs. Access to these rooms are provided by door openings finished with plain door frames held in place with mature machine cut nails. The interior chimney stack protrudes into the northern doorway, suggesting that the chimney was a later addition. These rooms have been plastered using riven lath. A false ceiling has been added which covers the joining of the roof rafters. The rooms are finished with a plain baseboard and the floors are sheathed with the original wide floor boards. The rafters are visible through a crawlspace on the east and west ends of the house. These rafters are hewn on all four sides. The vertical studs appear to have been milled using an up-and-down saw mill.

The interior of the southern, one-room addition is accessible one step down from the main block of the house. This addition has exposed ceiling rafters which are all circular sawn. The room is finished with beaded door and window frames, and a plain baseboard.




BOUNDARY SURVEY
