ST. JEROME'S CROSSROADS HOUSE

The St. Jerome's Crossroads House, a long, narrow, one-story-plus-attic frame house, began as a small, two-room frame structure with two exterior chimneys built against a brick north end wall. This first stage of circa 1800 was extended on the south in the early 19th century by a hall and single room addition with a single end chimney. The existing beaded clapboards, roof dormers and shed-roofed porch date from this period. The house was again extended at the south end by a one-room addition circa 1860-1900.

In 1792 Thomas Griffin devised the "lower part of my plantation, part of Griffin's Choice to my daughter Elizabeth." Elizabeth married Levin Thomas and the property was assessed in his name in 1790, including a frame dwelling. The Thomases' daughter, Priscilla, married Joseph C. Williams and they were living here in 1824. In 1837 Jenifer Taylor bought the property from Williams. His daughter, Ann Caroline Taylor, wife of William McKay, inherited it. The McKays' sons owned the property until the 20th century.
