The Pride of St. Mary's Lodge No. 1120, IBPOEW, is significant as the only Elks Lodge in St. Mary's County with a predominantly African-American membership. Founded in the 1940s, membership in the Lodge peaked in the late 1940s and early 1950s at 90 members. The Lodge remains active, sponsoring humanitarian projects such as a scholarship fund for local students.

According to Edward Smith, the building which houses the Elks Lodge was built by Joseph Bennett for use as a bar in the early 1940s. The Elks purchased the property in 1945. Meeting space in the Lodge is also shared with members of Masonic Temple No. 782.

The Pride of St. Mary's Lodge is located on the east side of Piney Point Road (Route 249). Unpaved roads flank the Lodge lot, extending from Piney Point Road to houses located in the wooded area beyond the Lodge. The Lodge building stands alone except for a new gable roofed picnic shelter located on its east side. The Lodge faces west with the gable roof oriented on a north/south axis.

Built in the 1940s, the Lodge is a two-story, frame building sheathed with artificial shingles. The foundation consists of cinderblock piers which are obscured by metal sheeting. The shallow pitched roof is covered with asphalt shingles. An interior brick chimney pierces the west roof slope. The longitudinal ends of the roofline are finished with exposed rafter feet.

The west (main) elevation has a central six-panel entrance door flanked on either side by a pair of six-over-six sash windows. The door is sheltered by a gable roof portico. A wheelchair ramp extends from the north side of the Lodge along the west elevation to the entrance door. The second floor is lit by three six-over-six sash windows. All windows have wide, plain surrounds with drip moldings.

The north elevation is pierced by a five-panel door and a window covered by plank shutters on the first floor. The second floor of this gable end is lit by one two-over-two and one six-over-six sash window.

The east elevation is pierced by two six-over-six sash windows and a four-light-over-three-panel entrance door. The door is sheltered by a gable roof portico. The second floor is lit by two six-over-six sash windows.

The south gable end elevation is lit by two six-over-six sash windows on both the first and second floors.

Although the interior was not seen, Edward Smith explained that there is a meeting room and small kitchen area on the first floor and a second meeting room on the second floor.

A gable roofed picnic shelter, constructed in 1994, is located in the yard behind the Lodge building.

Membership began to decline in the 1960s, and currently averages somewhere between 35 and 50 members. Meeting space in the Lodge is also shared with members of Masonic Temple No. 782.


