Swann's Store and Hotel is significant as the only summer boarding house that still stands at Piney Point. Although both the hotel and store have been significantly altered in recent years, these buildings are the only remnants of Piney Point's history as a popular summer resort during the late nineteenth and early twentieth centuries.

Alice J. Swann, wife of schooner captain James Thomas Swann, purchased three acres of "Part Pridgett's Land" from her grandmother, Mary A. Travers, in 1883 for \$500. According to one source, she and her husband erected a log dwelling here. Soon after establishing their home, the Swanns opened a grocery and general store on the property. The Piney Point post office occupied a portion of the Swann store off and on from 1886 until 1960.

Sometime prior to 1912 the Swanns began to take summer boarders. These visitors came from up and down the east coast. Usually, they arrived at Piney Point by steamboat from Washington, Baltimore, Virginia, and New York. Once the steamboat had docked at Piney Point Beach, a member of the Swann family would transport guests and their luggage from the landing to the hotel by buggy. Boarders stayed for a week, a month, and sometimes for the entire summer. In the 1920s, B. Gorman Swann built a series of one-room bungalows to house additional boarders.

During the 1940s, the installation of the Torpedo Test Range at Piney Point provided Swann's Hotel with an influx of customers. In the 1960s, business at the hotel had begun to slow. By 1970 the hotel was closed, although the cottages continued to be rented. In 1989 Swann's Hotel complex was renovated and reopened for business.

Swann's Store and Hotel is located on the east side of Route 249 at Piney Point in St. Mary's County, Maryland. The hotel is a large two-story, ell-shaped structure while the store building, which also houses a bar and restaurant, is a smaller two-story building that stands on the shore of St. George's Creek. A wharf extends into the creek from the south side of the store. An asphalt parking lot separates the store and the hotel. Between the two buildings stands a cinderblock, gable-roofed building that once served as a concession stand. A series of three one-story cottages dating to the 1920s are located south of the hotel and store buildings. The hotel, which now has a U-shaped footprint, faces east with the principal gable oriented on a north/south axis. The store faces west with the principal gable oriented on an east/west axis. Both buildings have been completely remodeled and wrapped with modern materials.

Built around 1900, the hotel foundation is not visible. Originally sheathed with weatherboard siding, it was covered with vinyl siding in the 1980s. The roof is covered with asphalt shingles.

The east (main) elevation is pierced by a series of three doors and five one-over-one sash windows. A modern two-story porch extends across this elevation. This porch replaced a one-story shed roof porch supported by turned post supports as illustrated in old photographs. The second floor of the hotel is pierced by six doors and three one-over-one sash windows. A cross gable pierced by a round window breaks the roofline.

The north elevation is pierced by two doors and six one-over-one sash windows on the first floor. A modern two-story porch extends across this elevation. The second floor of the hotel is pierced by six doors one one-over-one sash window. A cross gable pierced by a circular window breaks the roofline at the east end of the elevation.

The west elevation of the main block is a gable end with cornice returns. The first floor is pierced by two one-over-one sash windows. The eave is pierced by a circular window. A one-story, gable roof addition pierced by five one-over-one sash windows extends to the south of the main block. The south elevation of the hotel's east wing is pierced by two doors on the first floor and five one-over-one sash windows on the second floor.

The south elevation of the main block is pierced by three one-over-one sash windows on the first floor and five on the second floor. The gable end of the western addition is pierced by two one-over-one sash windows. The gable end of the eastern ell is pierced by one one-over-one sash window on the first and second floors.

Alice J. Swann, wife of schooner captain James Thomas Swann, purchased three acres of "Part Pridgett's Land" from her grandmother, Mary A. Travers, in 1883 for \$500. According to one source, she and her husband erected a log dwelling here. Soon after establishing their home, the Swanns opened a grocery and general store on the property. In the March 11, 1886 issue of the newspaper The St. Mary's Beacon, J. T. Swann advertised for rent "the Store and large grocery, Good Wharf, 10 pin alley, dwelling, and comfortable tenant house, and stable including four acres of fertile land and...my oyster ground." In 1886 James Thomas Swann was appointed post master of Piney Point during which time the post office was located in the Swann store. The post office continued to occupy a portion of the Swann store off and on until 1960.

Sometime prior to 1912 the Swanns began to take summer boarders. These visitors came from up and down the east coast. Usually, they arrived at Piney Point by steamboat from Washington, Baltimore, Virginia, and New York. Once the steamboat had docked at Piney Point Beach, a member of the Swann family would transport guests and their luggage from the landing to the hotel by buggy. Boarders stayed for a week, a month, and sometimes for the entire summer.

Every morning the day began with the rising bell, a hand bell run by a black woman known by the family as "Aunt Lizzie." At 8:00 A.M. the breakfast bell was rung. Breakfast consisted of fried fish, hot rolls, corn bread, french fried potatoes, bacon, and eggs. Throughout the day many of the guests spent their time bathing or fishing. Dinner was served at noon and consisted of potatoes, vegetables, and a different meat every day. Dinner was always followed by dessert. Supper was served at 4:00 P.M. This light meal featured fried fish or meat. Meals were always served family style in

7.1 Description

The interior of the hotel once housed a dining room, kitchen, and living room on the first floor and guest bedrooms on the second floor. The interior has been recently reworked to accommodate more guests.

The cottages, some of which are duplexes, are sheathed with vinyl siding and roofed with asphalt shingles. Although their exterior form remains much the same, the interiors have been reworked.

Built around 1885, the store is now covered with vinyl siding and roofed with asphalt shingles. The foundation is not visible

The west elevation of the store consists of a shed roof addition across the first floor pierced by a window. The gable end of the elevation is pierced by a modern Palladian window. The verge of the gable is sheathed with fish-scale shingles. To the south of the gable end is a two-story tower capped by a pyramidal roof. A portion of the tower is sheathed with fish scale shingles. It is pierced by a rectangular window on each side.

The south elevation of the tower is pierced by a doorway. The first floor of the main block is pierced by a series of octagonal windows on the first floor and by three pairs of one-over-one sash windows on the second floor. An interior brick chimney pierces the south roof slope. A wood deck is located on the south side of the store and extends out over St. George's Creek as a wharf.

The east elevation consists of a modern addition across the first floor that serves as a restaurant. The second floor is pierced by two one-over-one sash windows.

The north elevation consists of the eastern addition that serves as the restaurant. Two shed roof additions are attached to this side of the store. One was built for use as a walk-in freezer. The other served as the Piney Point post office for many years.

The interior of the store consists of one large room. General merchandise continues to be sold here. The walls are sheathed with wainscoting. To the north of the store room is a small room that currently serves as an office. Originally, the post office was located here. A three-light-over-three-panel door opens from the store into a hallway where the bar was once located. Beyond the hall is the newly constructed restaurant.

8.4 Description

the main dining room which seated up to one hundred people. Both guests and the Swann family dined together.

The Swann family lived in a two-story building situated behind the hotel. The house had eight bedrooms. The family used the main hotel living room as their own. Originally, the hotel consisted of forty rooms. On some occasions, especially on holidays when the hotel was full, it was necessary for family members to give up their bedrooms to guests. In the 1920s, B. Gorman Swann built a series of bungalows to house additional boarders. These one-room quarters were used for sleeping only. Each room was equipped with a slop jar, and bathrooms were located outside.

The successful operation of Swann's Hotel was due not only to the cooperation and hard work of the family but also to the reliability of their employees. The cooks and waitresses that provided guests with their three daily meals were local African American women. On weekends and holidays Mr. Swann would often transport these hotel workers between their homes and Piney Point. The closure of the hotel in the 1960s was partly the result of the unavailability of this work force.

During the 1940s, the installation of the Torpedo Test Range at Piney Point provided Swann's Hotel with an influx of customers. During the week, many of the men from the base spent their leisure time at the bar. In the 1960s, business at the hotel had begun to slow. By 1970 the hotel was closed, although the cottages continued to be rented.

The Swann's Hotel complex was renovated and reopened around 1989. At this time the main hotel building was reworked. The community living and dining areas were divided for use as individual bedrooms and the second floor bedrooms were fitted with exterior entrances.
