The Joseph Brennan Norris House is significant as a typical example of those houses built by St. Mary's County farm families in the 1930s. While the interior of the modest house has been altered, the exterior configuration is little changed. Now owned by the state, the two-story, frame dwelling is occupied by tenants. The surrounding fields continue to be farmed by Norris family members.

The property on which the Norris House stands has been known variously as "Long Fields," "Long Old Fields," "Cecils land," and "Lusby's land." This property was first acquired by the Norris family in 1897. At that time, John F. A. Norris and William W. Norris purchased the 263 acre tract of "Long Old Fields" from Thomas and Mary Lynch for \$1800. In 1916, the Norris brothers divided the land equally between them.

In 1924, John Norris transferred a 65 acre portion to his son Joseph B. Norris. Following a fire that destroyed the dwelling house on the property, Joseph Norris built the current structure in 1933. He and his family continued to live on the property until 1976, when it was sold to the State Department of Natural Resources.

The John Norris House is located at the end of an unpaved road off of Norris Road in St. Mary's County, Maryland. There are a series of agricultural outbuildings on the property. Cultivated fields and woodland surround the house which is located on St. Mary's State Park property. The house faces south with the roof oriented on a north/south axis.

Built in 1933, the two-story, two-bay structure is sheathed with artificial siding. The roof is covered with seamed metal. The foundation, which probably consists of brick piers, is not visible.

The south (main) elevation consists of a four-light-over-three-panel entry door and a six-over-six sash window with molded, narrow surrounds. A shed roof screened porch extends across this first floor. The second floor of this gable end elevation is pierced by two six-over-six sash windows. The eave is pierced by a louvered vent and is finished with cornice returns.

The east elevation is pierced by two pairs of six-over-six sash windows with molded, narrow surrounds on the first floor. Three six-over-six sash windows with wide, plain surrounds pierce the second floor.

The north elevation consists of one six-over-six sash window and one two-over-two sash window with molded narrow surrounds on the first floor. The second floor is pierced by two six-over-six sash windows. A louvered vent pierces the eave which is finished with cornice returns.

The west elevation consists of a one-story, projecting shed roof wing that extends across the full width of the first floor. The north end of this wing was originally an open stoop fitted with an entrance door. It was enclosed in 1968. The wing is now pierced by a modern door and two six-over-six sash windows with molded, narrow surrounds. Two six-over-six sash windows with wide surrounds pierce the second floor. An interior brick chimney pierces this west roof slope of the house.

The interior of the house consists of one large parlor on the first floor. An open string stair with a square newel post and square balusters is located against the west wall. French doors originally opened from the parlor to the dining room in the northeast corner of the house. A single doorway provides access between the two rooms now. The kitchen is located in the northwest corner of the house. The second floor was not seen, but consists of three bedrooms and a bath.

7.1 Description

Nine outbuildings stand on the property. Closest to the house stands a frame structure sheathed with weatherboard siding and roofed with corrugated metal. This building faces south with the gable roof oriented on an east/west axis. Two vertical panel doors pierce the south elevation. The interior is divided into two separate rooms. One room served as a meat house, while the other was used for storage.

A wood shed is also located near the house. Sheathed with asphalt shingle siding and roofed with corrugated metal, this building is currently used for storage.

Three gambrel roof barns are located to the north and west of the house. These barns are sheathed with vertical siding and roofed with metal. The barn located closest to the house was used for the storage of tobacco machinery. The two barns located west of the house were used for the storage of tobacco. A fourth tobacco barn, located west of the house, has a gable roof.

Located next to the barns are three smaller structures. One is a shed used for the storage of hay. This building is sheathed with vertical siding and roofed with seamed metal. Next to the shed is a corn house, supported by concrete blocks. It is sheathed with vertical wood siding and roofed with corrugated metal. A small building sheathed with weatherboard siding and roofed with asphalt shingles, probably a pump house, stands nearby and is covered with overgrowth.



NOTES: In 1869, Jarboe contracted with Spencer to purchase this land. Now that Jarboe has paid the full purchase price, Spencer transfers "Long Fields" formerly "Cecil" or "Lusby land" and owned by James E. Crane being 263 acres. Price: \$2000

It remains unclear how the Spencers acquired this property. There is no deed on record between Crane and Spencer, to Spencer, or to Crane that references this land under these tract names. Further, in James E. Crane's will of 1861 (JTMR 1/87), he divides all of his estate between his sons William Crane and James Crane. There is no deed from them in the land records that references these tracts.

Benjamin Tippett describes the metes and bounds of "Long Fields in Woolsey Manor" in his Surveyor Log Book (see page 276). He notes that it was originally surveyed for Col. Uriah Forrest on September 24, 1789 and patented to James Hopewell on November 18, 1796. He also notes that he resurveyed the land for John T. Jarboe on June 1, 1868.
