Based on the information provided by SHA, Thomas Spencer House does not meet the National Register Criteria for individual listing. Part of Culpepper is significant as an example of a modest farmhouse built around the turn of the nineteenth century in St. Mary's County. Notably, the exterior of the main block is well-preserved. Although the house is located next to Route 235, a buffer of trees protects it from the heavily trafficked route.

Built around 1900 by the heirs of Thomas Spencer, this house was purchased by Dora D. Clarke in 1919. According to Dorothy Stone, the granddaughter of Dora and Thomas Clarke, the house is built of oak beams. At the time of the Clarkes' purchase, a small grocery store was attached to the northeast corner of the house. The store was vacant and in poor repair and was soon demolished by the Clarke family. During the Clarke ownership, a barn, wood house, meat house, and chicken house stood on the property. They raised corn and tobacco on the farm and also kept pigs, chickens, a cow, and a horse.

Between 1932 and 1936, the California Post Office was located in the Clarke house. Originally located in a store on the corner of Route 235 and Rolling Road, the store burned around 1932. Postmaster John Gross then hired Dorothy Stone to act as his assistant and set up the post office in the center hall of her home. The office consisted of a desk, a safe, and a series of mailboxes. At that time, about twenty-five customers and mail carrier Nace Anderson frequented the post office.

Part of Culpepper is located on the south side of Route 235 in California in St. Mary's County, Maryland. Obscured by a line of trees, the house stands on the edge of the old railroad bed. Two outbuildings stand on the property. The house faces north with the principal gable oriented on an east/west axis.

Built around 1900, the main block of the two-story, frame dwelling has a center hall, single pile plan. The house is supported by a brick pier foundation and is sheathed with weatherboard siding. The roof is covered with corrugated metal. A one-story, three bay kitchen wing extends to the west and a one-story, shed roof wing extends to the south.

The north (main) elevation consists of a central four-light-over-three-panel door with a single light transom flanked by a six-over-six sash window on either side. A shed roof porch supported by chamfered posts extends across the full width of the first floor. The porch has a cement floor and plywood ceiling. The second floor of the main block is pierced by three six-over-six sash windows. The roofline is broken by a cross gable and pierced by a six-over-six sash window. A one-story wing extends to the west. This wing is pierced by three six-over-six sash windows with wide surrounds.

The west elevation of the main block is blind. An interior brick chimney pierces the roof ridgeline. The west end of the one-story addition is pierced by one six-over-six sash window with wide surrounds.

The south elevation of the kitchen wing is pierced by a four-light-over-three-panel door which opens onto an enclosed porch addition. The main block is pierced by one six-over-six sash window. Most of the first floor is obscured by a one-story, shed roof addition pierced by two six-over-six sash windows and a thirteen-light-over-two-panel door. The second floor of the house is pierced by three six-over-six sash windows.

The east elevation of the main block is blind. An interior brick chimney pierces the roof ridgeline at this east gable end.

The interior consists of a center hall with an open string stair. The stair baluster consists of simple square posts. A parlor is located east of the stair hall and a dining room is located to the west. The rear shed roof addition consists of a bathroom and back bedroom. The kitchen and a pantry is located in the west wing. The second floor of the house consists of two bedrooms and a bathroom.

Continuation Sheet 7.1 Description

The Thomas Spencer House is located in a rapidly developing area of St. Mary's County in the environs of California, near the intersection of Three Notch Road (MD 235) and Old Rolling Road. The 7.75 acre site is primarily woodland, but was evidently used for the cultivation of tobacco at one time. It is currently zoned for commercial development and on the market.

The site is very rundown and poorly maintained. It is composed of a probable late nineteenth century frame, two part dwelling, a shed, and the remains of a dilapidated and overgrown barn. The latter two buildings were constructed during the ownership of the Clarke's ca. 1945, according to a family descendent. The small barn was unreachable due to the heavy overgrowth.

The two-part dwelling is composed of a three bay wide, two-story, principal section with a broad cross gable interrupting the gable roof which parallels the north facing entrance facade. The fenestration, composed of six-over-six lights, is regular, with a small window near the apex of the cross gable. The entrance, with a simple, two-pane transom, is sheltered by a one-story shed roofed porch carried on simple square posts. The window and door surrounds are unmolded. Two simple brick chimneys are located inside the end walls at the apex of the gable roof built to accommodate stoves. There are vertical cornerboards on both parts of the dwelling.

There are no windows on either the east or west end walls. The fenestration on the rear (south) elevation is irregular, with the lower, westernmost window offset toward the east. Two shed roofed porches were either enclosed or added by the Halls in the last few decades. The one on the east, which continues the plane of the west wall of the two-story structure, is sheathed with vertical boards. The one on the west, which is partially screened, projects southward from the one-story addition.

This one-story addition, which continues the south plane of the principal section and is set back from the plane of the entrance facade, is also sheathed with horizontal cladding. The north elevation has three six-over-six lights, with unmolded architraves, and the end wall (on the west) has one centered window. The south elevation has no windows, and the easternmost bays are sheltered by the projecting, partially enclosed porch, which shelters a doorway. This one-story section was reportedly built in the third quarter of the twentieth century in the area where a small addition stood which housed a small store in the first decade of the twentieth century. By 1916 the business had been disbanded for some time and the building was deteriorating.

The two part dwelling, utilized as a rental property in the last few decades, and subject to considerable damage during that period, was heavily altered in the last 40 years during its

ownership by the Hall family. Almost all of the original lathe and plaster was removed and replaced by sheet rock, floors were replaced, moldings removed and the exterior completely re-sheathed with wide horizontal boards.

Evidently the California post office was then temporarily located in the house in the 1930's. According to Ms. Dorothy Fenhagen Stone, the California Post office located near the intersection of MD 4 and Md 235 burned in September, 1931. Postmaster John Grass asked Mrs. Dora Dorcus Clarke, who owned and resided in the Thomas House at the time, if she would allow a temporary re-location of the facility while a search ensued for a new building. A small alcove was created on the east side of the center hall for the operation.


It is highly possible that the post office was moved across Three Notch Road (MD 235) to the Abell Store, as Beatrice Abell is noted as having been a postmaster prior to the fire, and could have resumed the position later. Records are not available, however, for the period following Mrs. Stones' tenure. She was the granddaughter of Mrs. Dora Dorcus Clarke.

Statement of Significance

The Thomas Spencer House is an extremely dilapidated dwelling which has been heavily modified in the last 40 years. Although the early history of this late nineteenth century structure is exceedingly sketchy, it appears that an auxiliary structure, no longer extant, may have been the location of a small store in the first decade of the twentieth century. The house proper was the location of the California post office briefly in the 1930's after the post office at Tubman's Store burned in 1931.

The only structures on the site are a small heavily overgrown tobacco barn, which is inaccessible, and shed dating ca. 1945.
