Sotterly Schoolhouse is significant as one of St. Mary's County's handful of surviving early twentieth-century school houses. While the interior has been completely remodeled for use as a dwelling, the exterior configuration of the structure is still recognizable as a school building. Sotterly Schoolhouse, also known as the Black Gate School, was used for the education of white children. A schoolhouse for black children, built around the same time, is located on Sotterly Gate Road about a mile west of this building.

In 1907 Elizabeth R. and J. Douglas Cashner sold 1 8/100s acres to the Board of County Commissioners for "for the purpose of erecting thereon a school building and using the same for the education of white children." Included in this deed was the provision that once the property ceased to be used for educational purposes, both the property and the school building would revert back to the Cashners.

By 1936 the school was abandoned. It was then sold by the Cashners to Herbert L. Satterlee. The schoolhouse has now been converted for use as a dwelling.

Sotterly Schoolhouse is located on the southeast corner of Steerhorn Neck Road and Sotterly Gate Road near Hollywood in St. Mary's County, Maryland. The school is perched on a wooded hill that rises steeply above Sotterly Gate Road. There are two outbuildings on the property. The school faces north with the principal gable oriented on a north/south axis.

Built around 1907, Sotterly Schoolhouse is supported by a continuous brick foundation and is sheathed with weatherboard siding. The roof is covered with corrugated metal covered with tar.

The north (main) elevation, originally the location of the main entrance door, is pierced by two replacement six-over-six sash windows. The eave is pierced by an octagonal window.

The west elevation is pierced by four original six-over-six sash windows with wide surrounds. These surrounds have an interior bead and are crowned with a simple drip molding.

The south elevation is pierced by a six-panel door and a six-over-six sash window. The door opens onto a wood deck and is sheltered by a gable roof portico. An octagonal window pierces the eave.

The east elevation is pierced by three original six-over-six sash windows and a modern six-panel door. This door, now the main entrance, is sheltered by a gable roof portico like that on the south elevation.

The interior has been reworked with the addition of a livable loft space and the addition of partition walls on the first floor. Photographs of the interior show that the school originally had twelve-foot ceilings sheathed with wainscoting while the longitudinal walls were covered with plaster. The gable ends of the interior were sheathed with wainscoting laid diagonally.

The largest of the two outbuildings on the property is a one-story, gable roof structure which serves as a photography studio for the current owner. The studio was built in 1993 and is located southeast of the main block. The second outbuilding is a small storage shed.

Also located on the property is an eighteenth or nineteenth century stone boundary marker with the inscription "T.B. No. 3, The Name Boundary of Sotterley."


