

Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*
 The William C. Dean house located on the corner of Iron Horse Lane and Sotterley Road was formerly noted in an Maryland Historic Trust survey conducted in July of 1995, as having significance as a example of Italianate style residential architecture in St. Mary's County. The overall appearance, while basically the same in form does not seem to illuminate the character evident in photographs from that time. Scroll sawn brackets and hand railing along the perimeter length of the front porch, which is continuous along the front façade, have been removed. A porch post is damaged, windows have been replaced, and exterior siding has been redone. Remodeling has altered a rear offset on the first floor. What was enclosed at the rear offset is now an open porch. Some qualities of the house's individual character within its surrounding does stand out by the overall form of the house, the hipped roof and general symmetry. The house is featured prominently, raised above the road level and with no visual obstructions. Although the Maryland Historic Trust survey notes the house to date from 1870, tax information says the primary structure was built in 1945.

The William C. Dean House is significant as an example of Italianate style residential architecture in St. Mary's County. Dating to around 1870, the exterior of the two-story, pyramidal-roofed, frame house is largely unaltered. Original features include the four-over-four sash windows, sidelighted four-panel entry doors, and front porch with scroll sawn woodwork. Currently unoccupied, the building has begun to deteriorate.

The Dean House stands on a portion of the tract "Fenwick Manor." Henry Jones purchased 242 acres of this property in 1875 as the result of a judgment in his case against G. Fred Maddox and John W. Mitchell. Jones immediately sold the property to George Lathrum for \$1300. In 1900, Leo and Mary Lathrum sold half of "Part Fenwick Manor" to William Columbus ("Lum") Dean for \$700.

The property remained in the hands of the Dean family until 1940. Ten acres, including the house lot, were separated from the remainder of the tract in 1970. In 1976, the lot was decreased to 1.04 acres in size.

The William C. Dean House is located on the west side of Sotterley Gate Road near Hollywood in St. Mary's County, Maryland. Three outbuildings, including a meathouse, a garage, and a tobacco barn, are located on the west side of the house. The house faces east.

Built around 1870, the house consists of at least two building periods. The main block is a square structure capped by a pyramidal roof. One room wings, stepped back from the main block, extends to the north and south. Only the southern wing is an addition. A one-story, shed roof addition is also located on the west side of the north wing. The house is supported by a brick pier foundation and is sheathed with weatherboard siding. The roof is covered with tar paper.

The east (main) elevation of the two-bay main block is pierced by a four-panel door with three-light-over-one-panel sidelights and a four-light transom. The door surround is narrow and has an interior bead. Both the transom bar and the door jamb are reeded. A pair of one-over-one sash windows with narrow surrounds and an interior bead pierce the wall surface to the north of the door. The second floor is pierced by two four-over-four sash windows with an interior bead. The main block is finished with a plain frieze, corner boards, and a cyma curve cornice. The two-bay north wing is pierced on the first floor by a multi-panel door with two-light-over-one-panel sidelights. A modern, replacement six-over-six sash window pierces the wall surface to the north of the door. The second floor is pierced by two four-over-four sash windows. The single-bay south wing, a later addition, is pierced by a four-panel door with three-light-over-one-panel sidelights. A one-story porch extends across the full width of the east elevation. The porch has a wood floor and a plywood paneled ceiling. The roof is supported by turned posts with scroll sawn brackets.

The south elevation of the main block is pierced on the first and second floors by a four-over-four sash window with a narrow, beaded surround. The south side of the south wing is pierced by one four-over-four sash window with a beaded interior surround on both the first and second floors.

The west elevation is pierced by three four-over-four sash windows on the first floor. A two-bay northern addition with a shallow hipped roof is pierced by a three-light-over-one-panel door. This addition is sheathed with board and batten and vertical siding. A metal stove pipe projects from the roof of this wing. The second floor is pierced by five four-over-four sash windows.

The north elevation of the north wing is pierced by a modern replacement six-

over-six sash window on the first floor and by a four-over-four sash window on the second floor. Exposed framing on this end of the wing reveals circular sawn down braces and studs. The north side of the main block is pierced by a four-over-four sash window on both the first and second floors. An interior brick chimney pierces the north roof slope of the main block.

The interior of the first floor has been considerably reworked. The main block consists of one open room on the first floor. An open string stair is located against the south wall. The steps are trimmed with sawn brackets and the baluster has been removed. A brick hearth, used most recently in conjunction with a wood stove, is located in the middle of the room. The south wing consists of one room on the first floor, accessible behind a four-panel door with a metal box lock. The north wing serves as the kitchen. A stair that leads to the second floor is located opposite the entrance door of the north wing. There are four bedrooms on the second floor.

Three outbuildings are located on the west side of the house. A meathouse sheathed with weatherboard siding and roofed with seamed metal stands closest to the house. A garage sheathed with vertical siding and roofed with seamed metal stands between the meathouse and the tobacco barn. The tobacco barn is sheathed with vertical board siding and is roofed with seamed metal.


