Constructed in the 1890s, the Sparks/Holley house represents a significant two story, two bay, frame dwelling situated on the banks of Breton Bay. In a deed between William F. Greenwell (grantee) and Laura W. Holmes, et al (grantors) dated September 1900, the conveyance describes the property as "now occupied by Wesley R. Sparks" and his wife Catherine Sparks. It goes on to mention that Sparks purchased the property from Frank N. Holmes in a previous deed. Unfortunately, no date or deed reference for this transaction is given and none could be found. While the dwelling's original builder is unclear, the house remains an excellent example of a late-nineteenth century residence. Its wrap around porch with turned supports and scroll-sawn brackets as well as a cross gable with fishscale siding typify decorative treatments during the timeperiod.

The Sparks/Holley house is a c. 1890s, two-story, frame dwelling with a gable roof located approximately 0.1 miles from the Leonardtown Wharf and Washington Street on Breton Bay. Located only a few yards from the Bay, the house was constructed on a slight slope and commands views of the water, Leonardtown wharf, and of nearby Buzzard Point. Other homes of similar size, style, and form are located near the dwelling.

The south or primary elevation consists of two, two-story sections separated by a vertical piece of trim. The section west of the trim, constructed in the 1940s, exhibits a concrete block foundation, aluminum siding (that is found throughout the house), and two pairs of one-over-one windows on the first floor and two single, one-over-one windows on the second floor. Composition shingles cover the gable roof that also exhibits an enclosed cornice. The west section of the elevation is the original dwelling. It exhibits a brick foundation, two bays--a two-over-two window and a modern glass door on the first floor and two, two-over-two windows on the second floor and a gable roof with a ridge line that runs contiguous with the western section's. The first floor bays are shaded by a wrap around porch with scroll sawn porch brackets and turned supports. This part of the elevation also features a cross gable decorated with fish-scale shaped wood shingles as well as two pieces of trim that cross each other.

The west elevation, or west gable end, consists of a gable roof entrance to the basement, a paired set of one-over-one sash on the first floor, and a single one-over-one window on the second floor. This elevation also reveals the rear part of the dwelling that consists of a shed roof addition to the original gable roof, two room dwelling. A modern door and casement window provide entry and light into the first story addition, while a two-over-two window provides light to the second floor of the original dwelling.

The north elevation features the gable end of the original dwelling, two shed additions to either side of the gable end, and the rear of the two-story, 1940s block. The rear of the 1940s block consists of two, one-over-one sash on the first and second floors and an exterior brick chimney flue. The gable end of the original block only exhibits a single, casement window.

The east elevation is the most altered of all the elevations. The shed addition to the north exhibits a large bay window, while the original block features sliding glass doors on the first floor and a bay window on the second floor. The wrap around porch, however, was retained as it provides entry through a modern glass door to the shed addition.

The interior of the original section retains some its original fabric. According to the owner, the original two rooms had been covered from wall to ceiling with beaded matchstick. At present only the front room has matchstick used as wainscoting and covering the ceiling. The front room also contains the open string stair to the second floor. This stair exhibits its original turned newel, but the balusters have been replaced. The rear room of the original block has been altered into a modern kitchen, but once contained a stair to the basement below that served as a root cellar. This cellar featured a ledge constructed of a large aggregate concrete that ringed three of foundation's four walls in order to facilitate this storage function.

After changing owners several times in the early-1900s, the house was purchased by Enoch B. Abell from Joseph and Lillian B. Mattingly in 1910. During his ownership, the house was lived in by a variety of tenants until it was purchased by William G. Holley in 1943. According to the present owner of the house, Jean Moulds, Holley made several additions to the home, but left the core two rooms of the house and the exterior decorations largely intact.








