Demolished to make way for a Hardee's restaurant, Whitehall was a 2 1/2-story, side hall/double parlor house of the mid-19th century. It was owned by Benjamin Gwynn Harris, a Leonardtown lawyer, at one time. Charlotte Spalding Fenwick ran a school here for many years, and later it was a Jesuit residence.
