The Captain Benjamin Foxwell House is a frame, three bay, two story, Italianate-style dwelling located on a promontory overlooking Breton Bay near Leonardtown, Maryland. Constructed in 1883-1884, the dwelling is not only architecturally significant, but also has important associations with a locally prominent schooner captain and the building contractors that he commissioned to build the house.

As a schooner captain, county commissioner, sheriff, and deputy commander of the Maryland State Fishery Force, Foxwell was well connected with the local political leaders and wealthy merchants, lawyers, and judges. Foxwell confirmed these connections with the construction of his house in 1883-1884. In the summer of 1883 Foxwell hired Stephen E. Norris and Andrew M. Garner to construct a frame house that overlooked his ancestral home near Foxwell's Wharf. Norris and Garner were well appointed contractors who had also built the house at Old Patuxent Farm (SM-527), St. Peter's Episcopal Church Rectory (SM-531), and renovated St. George's Episcopal Church at Poplar Hill (SM-12). Called "Mt. Chimborazo," Foxwell's dwelling was constructed in the Italianate-style and featured symmetrical fenestration, compartmentalized interior spaces, and an elaborately decorated stair case - all traditional components of locally designed and constructed dwellings.

An account in the January 10, 1884 issue of the St. Mary's Beacon, describes the house as occupying "a position overlooking Brittan's Bay as far down as Ragged Point [and] is quite

The Captain Benjamin Foxwell house is located on the west side of Camp Calvert Road approximately 0.1 mile from the intersection of Camp Calvert Rd. and Maryland Route 5 near Leonardtown, Maryland. Oriented on an east/west axis, the house is situated on an uneven 1.01 acre tract that overlooks Foxwell's Wharf and nearly all of Breton Bay. The house is bounded on the west and north by wooded tracts, to the south by a descending hill, and to the east by the road.

The Captain Benjamin Foxwell house, constructed in 1883-1884, is a frame, two story, three bay, center passage, double-pile dwelling with a hip roof pierced by a single brick chimney flue. The house was constructed on a common bond brick foundation. Its circular sawn frame walls are sheathed with horizontal lap siding fastened to the frame with machine cut nails. The dwelling features a wide frieze and box cornice with a broad overhang. The roof is covered with raised seam metal.

The east or primary elevation is pierced on the first floor by a centrally located, four panel door with a three light transom flanked on either side by two-over-two, double-hung sash windows with functional louvered shutters. All of these bays are shaded by a porch supported by four square columns. The floor of the porch is even with ground level and has been covered with brick pavers. This porch replaced an earlier porch that featured turned posts and scroll sawn brackets. The second floor of this elevation is pierced by three, two-over-two windows.

The south or water side elevation is pierced by a centrally located set of French doors--each door with two panes--that are flanked on either side by two-over-two windows. An exterior end brick chimney, a later addition, is located in the area between the east window of this elevation. All of these bays are shaded by a similarly constructed two story porch supported by four square columns. The second story is pierced by a centrally located door flanked by two-over-two windows. The porch on the second story is enclosed with a balustrade and the cornice features decorative rafter tails and a dentilated cornice all added in the 1980s renovation. Attached to the west side of this elevation is a one story addition with a poured concrete foundation and a shed roof. It is pierced by a set of paired one-over-one windows. This addition was added in the mid-twentieth century.

The west elevation consists of two later shed roof additions and the main block. The south shed addition is pierced by a two-over-two window. The north shed addition is pierced by a set of sliding glass doors and a fixed single pane window. The north shed addition also features a roof covered with asphalt shingles. The second floor is pierced by three, two-over-two windows.

The north elevation is pierced by a door and two, two-over-two windows. The door is covered by a gable roof eave supported by a pair of brackets. The second floor is pierced by three, two-over-two windows.

The interior exhibits a center passage, double pile plan. The center passage features a decorative stair ornamented by a turned newel and banisters and scroll sawn brackets. The body of the stair is covered with beaded vertical matchstick. The passage permits entry into every space of

The Captain Benjamin Foxwell House is a frame, three bay, two story, Italianate-style dwelling located on a promontory overlooking Breton Bay near Leonardtown, Maryland. Constructed in 1883-1884, the dwelling is not only significant for its architectural integrity, but also features important associations with a prominent schooner captain and several local building contractors.

Born on September 21, 1835, Benjamin Foxwell began his maritime career as the captain of a freight vessel (United States Census, St. Mary's County, 1860). Foxwell, however, soon turned to oystering and in the late-nineteenth century he ran a "buy boat." A buy boat was essentially a boat, usually a bugeye, schooner, or pungie, that could measure the oysters and then transfer them to the market for the oystermen. The buy boat would then return from the market with supplies for the respective oystermen.

In the 1870s, Foxwell turned his interests towards public service. From 1873-1875, he served as the county sheriff and in 1875 until 1877 he served as a County Commissioner. The oyster trade during the late-nineteenth century, however, was beset by violence as oystermen often clashed with Virginia watermen during a series of fishing boundary disputes. On May 25, 1896, Foxwell was named Deputy Commander in charge of the vessel "Bessie Jones" of the Maryland State Fishery Force and sworn into office by J. Parran Crane Associate Judge of the Seventy Judicial District. While his stint as the commander only lasted a year or two, an incident involving the "Bessie Jones" would later make headlines. In 1906 the "Bessie Jones" and its then Captain George W. Maddox was involved in a shootout with the schooner of an oysterman named Alex Harris out of Oxford on the Eastern Shore. Harris' boat was illegally dredging near Cobb bar, and the boisterous Harris claimed that no one could stop him. One of Maddox's mates, Douglas Russel, did just that for he shot Harris in the chest killing him instantly (Wennersten, The Oyster Wars of the Chesapeake Bay, 92-93). This incident captures the violence that Foxwell tried to quell in 1896.

As a schooner captain, county commissioner, sheriff, and deputy commander Foxwell was well connected with the local political leaders and wealthy merchants, lawyers, and judges. Foxwell confirmed these connections with the construction of his house in 1883-1884. In the summer of 1883, Foxwell commissioned Stephen E. Norris and Andrew M. Garner to construct a

7.1 Description

the first floor. The doorway leading to the south parlor has been removed and widened. The partition between the two south rooms has also been removed creating a single room on the south side. The north dining room retains its original decoration including a chair rail and baseboard. A four panel swinging door leads to the newly remodeled kitchen. This door features a circular hole, almost like a port-hole, for a round piece of glass. The second floor was not accessible at the time of the visit.

A small basement, whose bulkhead entry is located on the north side of the house, features a small excavated space with whitewashed brick walls. Curiously, one of the brick walls is pierced by a window. The window, however, is well over two feet from the actual exterior foundation wall. This detail suggests that the excavated foundation might date to an earlier structure.

The house also features several archaeological features including a modern brick building that once stood approximately 10 yards to the northwest of the house and a trash pit located to the north of the house near a steep ravine.

Two horse barns constructed in the 1980s, a workshed dating from the mid-twentieth century, and a brick lined well are located a short distance to the northwest of the house.

The building's symmetrical facade, compartmentalized interior spaces, and decorative stair elements represented traditional components of locally designed and constructed dwellings. On January 10, 1884, a correspondent for the St. Mary's Beacon described the finished house during a visit. He states, "The dwelling, which occupies a position overlooking Brittan's Bay as far down as Ragged Point, is quite an imposing structure, is 32 x 34 feet, has 8 rooms with a closet in each, an 8 foot passage and is neatly and substantially finished in all details. Indeed, we never remember seeing finer work on any house."

While the Beacon's unequivocal praise for Norris and Garner's work reasserted the important theme of improvement in the county, the newspaper also notes that "Most of the lumber was prepared at the sawmill of Mr. A. F. Fenwick, Jr., the bricklaying was done by Mr. Garner and the plastering by Messrs. Sullivan and Bland. Capt. Foxwell assures us that the total cost of the house, material, work and all will not exceed \$4000. The building compares favorably with any in our section and proves that a good lumber can be prepared at home and as fine building done by our native talent as can be obtained by sending to the cities for workmen and material." This brief description of the building, its contractors and subcontractors, as well as its suppliers, provides a vivid glimpse into the process of building in St. Mary's County. While colored by the Beacon's overarching agenda of civic and domestic improvement as well as mercantile self-sufficiency, the description captures a turning point in the county's construction industry. Interestingly, only a few months before the building of the Foxwell house, the Beacon reported on June 7, 1883 that Mr. Norris was in Baltimore to purchase lumber for building the house at Old Patuxent Farm (SM-527).

On October 31, 1904, Foxwell died at the age of 70 at Mt. Chimborazo. His wife Annie M. Foxwell died nine years later on December 27, 1913. The house remained in the Foxwell family until 1942 when it was purchased by the President of the First National Bank of St. Mary's R. Bascom Broun and his wife Ann M. Broun. The Broun family made several changes to the building including the removal of the wall separating the two south rooms on the first floor. They also erected two shed roof additions, replaced a window on the south elevation with an elongated set of French doors, and also added an exterior end chimney on the south elevation as well. The building is currently owned by Eugene and Sally Carter but occupied by their son Mark and his wife Amy who plan to gradually restore the dwelling.





