

Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*

A Maryland Historic Trust Library State Historic Sites Inventory Form dating from June of 1997, features a detailed physical description and narrative regarding the significance of the Thompson House, or what was previously known as "Jones Adventure." The house currently remains in essentially the same physical condition noted in the document and in photographs from that time. The house is visually impressive with detailed architectural adornments and detailing. Although updated in materials, the restoration effort appears to have done justice to the integrity of the original structure. (Fake shutters are considered to be a reversible addition.) Cultural significance derived through the early modifications to the structure, and the continuous family ownership by the descendants of a prominent local figure dating from the mid nineteenth century are noted in the survey and bolster the notion of inclusion on the National Register.

"Jones Adventure" or the Thompson House is located on the south side of Sotterley Road approximately 0.2 miles northeast from the intersection of Sotterley and Old Three Notch Roads in Hollywood, Maryland. The house is oriented on a west/east axis and is situated down a short dirt drive that runs perpendicular to the house and creates a circle just in front of the west or primary elevation. The dwelling is bounded on three sides by cultivated fields and to the northwest by the road. To the east of the house are a series of outbuildings that include a cow barn, two storage sheds, and a garage. The rural setting around the house has been maintained as several late-nineteenth and early-twentieth century houses are situated nearby such as the William C. Dean house (SM-498).

The Thompson House is a frame, single pile, center passage, two-story, five bay, dwelling with two exterior end brick chimneys and a two story, three bay, rear ell. The entire house rests on a brick pier and cinder block foundation and the walls are covered with vinyl siding. This siding covers the original clapboard that was fastened to the frame with machine cut nails. The gable roof of the main block and rear ell is covered with asphalt shingles.

The primary or west elevation features a centrally located four panel door with sidelights flanked on either side by two, symmetrically placed, one-over-one, double-hung sash windows. These bays are shaded by a porch roof that is supported by a series of turned posts with scroll-sawn brackets. The second floor is pierced by six windows. The center bay features a paired set of one-over-one windows with a wooden window hood or lintel. This center bays is flanked on either side by two, one-over-one windows. Immediately above the center bay is a centrally located, circular, five colored-light window and two, semi-circular, three colored-light windows. These windows are situated in a centrally located cross gable that projects from the building's gable roof. This cross gable is decorated with a vergeboard. The raking cornice of the entire elevation is further ornamented with scroll sawn trim.

The south elevation consists of the gable end of the main block and the side of the rear ell. The gable end does not feature any openings but a large exterior end, five-to-one common bond chimney with one set of shoulders extends beyond the roofline. The rear ell is pierced on the first floor by a sliding glass door that opens onto a screened-in porch. Part of the porch is supported by turned posts. To the east of the porch is a one story modern addition that wraps around the ell on the west side. This addition is pierced by a single light window. The second floor of the ell is pierced by three, one-over-one windows. A brick chimney flue extends from the center of the ell's roof. This elevation does not feature a decorated cornice.

The west elevation consists of the rear of the main block and the gable end of the rear ell. The main block is pierced by two, one-over-one windows on the first and second floor. The first floor of the ell features the one story modern shed addition. This addition is pierced by two one light windows and a modern door. The second floor is pierced by a one-over-one window. At the juncture of the addition and the ell, an exterior end brick chimney flue extends up the length of the ell's gable end.

The north elevation consists of the gable end of the main block and the side of the rear ell. The west addition to the ell is pierced by a one light window. The ell, itself, is pierced on the

Situated on the east side of Sotterley Road near Hollywood, Maryland, the Thompson House represents a significant two story, frame dwelling constructed in the 1870s. While much of the house's interior and exterior details suggest an early-twentieth century construction date, the exterior end, brick chimneys point to an earlier c. 1870s date. This disparity reveals how the house was significantly remodeled in the first decade of the 1900s as domestic sensibilities and family size changed. While this remodeling makes the house a significant example of architectural modification, the Thompson dwelling is also important for its long association with Samuel C. Thompson and his descendants.

Initially built by Samuel C. Thompson, a prominent local farmer, just after the Civil War, the house has been passed down through several generations of the Thompson family and is currently owned by Samuel's grandson J. Howard and his wife Kerrie E. Thompson. Situated on the tract called "Jones Adventure," the dwelling and surrounding property was just one of several properties owned by Samuel C. Thompson in the mid to late-nineteenth century. A deed dated September 26, 1901 listed these properties as "Charles Kirkland" and "Watch Harm Strife" 240 acres, "Mannings Purchase" and "Dodge Hills" 192 acres, "Part Spring Neck" 100 acres, "Somerville Bought" 100 acres, "Part Resurrection Manor" 39 acres, and "Part Resurrection Manor" 25 acres.

While the house has been covered with vinyl siding, much of the building's architectural fabric and building details have been carefully restored by the present owners. The turned porch posts and scroll sawn brackets, the decorative eave-work as well as the interior stair passage's turned newel, banisters, and scroll sawn brackets. Overall, the house not only documents the gradual changes to the county's agricultural landscape from the mid-nineteenth century to the early-twentieth century, but also chronicles the lives of the Samuel C. Thompson and his descendants. A more detailed architectural investigation is warranted to gain a better understanding as to the house's original appearance.

7.1 Description

first floor by two, one-over-one windows and a door. The second floor is pierced by three, one-over-one windows. The raking cornice of the ell as well as the main block is decorated with the identical scroll sawn trim that is found on the west side. The main block is pierced on the first and second floor by a one-over-one window. These windows lie to the west of an irregular common bond, exterior end, brick chimney with a stepped base and one set of shoulders. This stack is somewhat smaller than the brick chimney found on the south side.

The interior of the main block is organized into a single pile, center-passage plan on the first and second floors. The shallow center passage is decorated with an open string stair that features a large turned newel and banisters as well as scroll sawn brackets. The passage permits entry to all parts of the house. The doors in the passage feature architraves with undecorated corner blocks. The passage is flanked on each side by a parlor that features a mantle. The mantle on the south parlor consists of two, flat, engaged pilasters that support a flat frieze decorated with a raised motif. A squared shelf lies just above the frieze. The mantle in the north parlor exhibits plain pilasters and a plain frieze and a curvi-linear shelf. The north parlor is linked to the rear ell by an expanded entry that was originally a door. The first floor of the ell consists of two rooms. The main block's second floor also features a center passage flanked on either side by a bedroom. The passage on the second floor also has an entry to the second floor of the ell. The ell was not investigated. The common rafter roof of the main block's constructed of circular sawn rafters that are mitred at the peak. According to the present owner, Howard Thompson, the roof of the ell is constructed in a different manner that suggests the ell was constructed or attached to the house after the main block was erected. Oral tradition relates that the original kitchen burned to the ground and was replaced by the present rear ell. Recent renovations to the house have also revealed that the original floor joists of the main block were half rounded logs hewn on one side to receive the flooring.

A series of early-twentieth century agricultural outbuildings extend to the west of the dwelling. This includes two storage sheds, a garage, and a cow barn. The cow barn features a pair of swinging doors for a carriage way on its west elevation. The rectangular plan building is sheathed with vertical boards and the roof, aligned on a north/south axis, is covered with raised seam metal. The interior was not investigated.

All of the heirs received these various tracts from Samuel C. Thompson, a substantial local landowner. Unfortunately, a search through the Grantee/Grantor Index could not substantiate who Thompson received the lands from.


