Situated on an agricultural tract that was once part of "Cross Manor," this modest, axial plan tobacco barn features many details that are typical for the building type and period. The framing is mortise-and-tenoned, the members are hewn and circular sawn, and cut nails were used for fasteners. The oral tradition surrounding the barn, however, is anything but typical. According the current owner Phillip Meagher, the barn was used by local African-American residents of Beachville as a meeting place and dance hall in the late-nineteenth century. Curiously, architectural evidence supports this local tradition. The shed side walls of the barn, for instance, are sheathed with vertical, circular sawn boards that have been whitewashed. Normally exhibiting a dirt floor, the barn utilizes plank floors. Further research is needed to ascertain the full significance of this otherwise conventional looking building.

The Barn at Part of Cross Manor lies on the north side of Beachville Road approximately 0.4 of a mile west of the intersection of Beachville Road and Maryland Route 5, near St. Inigoes, Maryland. Situated in the midst of a soybean field well off the road, this agricultural building is oriented on a north/south axis. A non-contributing one story, ranch-style dwelling is located to the west of the barn and lies perpendicular to a dirt drive that extends from the road. The barn, house, and field are part of a 31.77 acre parcel that is ringed by a series of wooded tracts.

The Barn at Part of Cross Manor, constructed c. 1860-1870 is a frame, tripartite tobacco barn composed of an axial plan center block with sheds descending off of its east and west sides. The barn's braced frame rests on a brick pier foundation. The exterior walls are sheathed with vertical boards fastened to the frame with mature cut and wire nails. The cornice is open and the roof is covered with corrugated metal. Judging from architectural evidence, it appears the west shed was constructed subsequent to the main block and east shed.

The south elevation consists of the barn's gable end. A centrally located door hung on modern hinges provides access in the main block. Part of the original door lies just above this entry and remains attached to a strap hinge. A door, now removed, once provided entry into the west shed. The asymmetrical roofline observed on the elevation represents the first hint that the sheds were constructed at different times. Architectural evidence, namely the circular sawn framing members and the use of wire nails, provide an early twentieth century date for the west shed while the east shed dates to the barn's initial construction. The east elevation consists of the largely open east shed that is only partially sheathed with vertical boards. The north elevation contains only a single doorway into the main block. Like the east elevation, the west elevation is only partially sheathed with vertical boards as it features an unbarred opening.

The barn's interior deviates from typical tobacco barn construction practices. The most significant difference is its plank floor. The floor is suspended by a series of large transverse joists that are hewn. The joists lie on sills that in turn are supported by the brick piers. Other than the floor, the framing of the barn follows period conventions. It consists of hewn, circular sawn, and pit-sawn members that are mortise and tenoned together. The framing lies irrespective of the seven five-foot rooms created by the horizontal tobacco poles. Three tiers of poles, a tier of common ties, and two tiers consisting common rafter collars were all used to hang tobacco. In order to bridge the width of the main block, "swinging tiers" suspended from the hewn common ties were utilized. The common ties also support the circular sawn false plate. This thin plate supports the feet of the common rafters. Each rafter pair is joined by two common rafter ties and again at the peak with a half-lap joint.

A second interesting feature is seen on the east side of the main block where a series of vertical, circular sawn planks have been fastened to nailers and then whitewashed. Nailing patterns seen on the outside face of the main block's west side indicate that boards also existed on this side until they were removed. Oral tradition has suggested that these vertical boards and aforementioned floor are evidence that local African-American residents of Beachville may have used the barn as a meeting and dance hall.

8.2 Significance

Tyler died, however, before Smallwood could fully repay Tyler and so a deed was never executed. In 1902, a deed was executed between Smallwood and Daniel C. Hammett, the executor for Allen C. Tyler. Smallwood, however, died before he could make full payment on the property, so his heirs were forced to sell the property.



Notes: The absence of a ban clause does not permit a more in-depth look at the past property owners. Research on the surrounding properties, however, suggest that Tyler's tract was once part of the larger Cross Manor. It is unclear when it was subdivided. Judging from the evidence of the existing barn and descriptions of the house that was demolished, it may have been between 1840-1860.
