The Henry Pilkerton Garage, constructed in the late-1940s, represents a significant example of a rural, automobile repair garage located in the Abell vicinity of St. Mary's County, Maryland. Managed and operated by Henry Pilkerton, the garage provided convenient automobile servicing for several years. James Gibson, a local oysterman and mechanic, remembers working at the garage between 1949-1951 making \$1.46/hour. Because of a particularly deflated oyster market, Gibson was forced to work as a mechanic. To many oysterman and crabbers, occupational versatility was born out of necessity as volatile markets often pushed waterman into farming, automobile repair, and boat building.

Mr. Gibson remembers that the Pilkerton garage was one of the only repair facilities in the seventh district as he noted Guy Chevrolet dealership in Clements as being one of the next closest. The garage was competent in repairing a wide variety of automobile models. DeSotos, Chevrolets, Hudsons, and even a Studabaker could be repaired by this rural shop. Only a few years after opening the shop, Henry Pilkerton moved to a larger car repair shop near the crossroads of Avenue, Maryland. The Henry Pilkerton garage is currently used for storage.

The Henry Pilkerton Garage is situated on the north side of Abell Road approximately 1 mile from the intersection of Routes 470, 242, and Abell Road near Abell, Maryland. Surrounded by level, cultivated fields, the building is oriented on a north/south axis and remains only 15 feet from the roadway. The garage is currently used for storage.

The garage, built in the late-1940s, is a one story, two bay, frame building with a low pitched, gable roof. Constructed on a continuous, poured concrete foundation the braced, circular sawn frame is sheathed with clapboard that is fastened with wire nails. The cornice has been left open and the roof is covered with raised-seam metal.

The primary or south elevation is pierced by two pairs of swinging garage doors. Each of the doors are constructed of vertical boards held together with horizontal battens. The west elevation is pierced by a door and two, now boarded over, windows. The north elevation is pierced by a door and two windows. Each of the windows consist of two fixed panes fitted horizontally next to each other. An interior brick chimney flue extends up from the north or rear wall. The east elevation's fenestration features three, two fixed-pane, windows and a slender doorway. Some of the clapboard on this elevation is covered over

Following the utilitarian nature of the building, the interior is entirely unfinished as much of the roof and wall framing has been left exposed.







ROAD CLASSIFICATION
