Standing on a slight rise at the intersection of Maryland Routes 5 and 235 (Point Lookout and Old Three Notch Roads respectively) in Ridge is the impressive Knights of Columbus Hall. This long, one story, frame building has been extensively remodeled, but the building still retains important associations with the surrounding community. The tract was first transferred to James Cardinal Gibbons, Archbishop of Baltimore on April 17, 1919. In 1923 the property was transferred to the St. Michael's Building Association and in 1925 the Ridge Chapter of the Knights of Columbus, a Catholic fraternal organization, hired Thomas Ridgell to erect a large one story frame building to house their various functions which included dances, parish meetings, monthly dinners, and variety of other public endeavors.¹ Today, the hall is still utilized by the organization and the surrounding community, but a series of changes that included removing most of the windows and sheathing the exterior with vinyl siding have altered its overall appearance.

The Ridge Knights of Columbus hall stands prominently overlooking the intersection of Maryland Routes 5 and 235 in Ridge, Maryland. Oriented on a north/south axis, the hall is located on the north corner of the intersection of this rural crossroads community. A large parking lot encircles the building thus linking the intersecting roads. These roads ring three sides of the 1 acre tract with the fourth side bounded by an auto repair shop.

The Ridge Knights of Columbus hall is a large, one story, axial plan, frame building with a series of rear additions. Initially constructed in 1925, the building was erected using many of the most modern building methods. The foundation, for instance, consisted of poured concrete and then the circular sawn frame was presumably sheathed with wood clapboard. This clapboard has since been replaced by vinyl siding. The wall and roof intersect at a box cornice and the roof is covered with raised-seam metal. A one story, frame wing ringed by a flat roofed cinder block skirt extends from the main block's north wall. This wing has been further expanded by a frame addition that is situated on the west side.

The gable front primary or south elevation is pierced by a recessed metal door. Frame extensions, added subsequent to the building's construction, flank the doorway. A large louvered vent lies near the apex of the roof.

The east elevation consists of the main block and the side of the masonry skirt. The main block does not feature any openings. A series of non-structural vertical columns protrude from the wall surface. Immediately in front of the masonry skirt is a handicapped access ramp that leads to a pair of metal doors.

The north elevation consists of the main block's gable end, the rear of the wing, and a side of the masonry skirt. The main block features a louvered vent near the apex of the roof, but like the rear of the wing, is otherwise unfenestrated. The masonry skirt is pierced by three small casement-like windows that lie near the eaves and a door.

The west elevation consists of the main block and the gable end of an addition that is perpendicular to the rear wing. The main block is unfenestrated, but like the east elevation features two non-structural columns that extend up the wall. The addition does not have any openings.

The interior consists of a large open space for meetings, dances, and other occasions, while the rear of the building largely consists of bathrooms and a fully equipped kitchen for food service.




