The Lanham House was most likely built *circa* 1940 and displays influences of the Craftsman/Bungalow style with its flared roof and shed dormers, however, the use of unpainted cinder block and metal casement windows is somewhat unusual. The Lanham House may have been associated with an agricultural parcel, however, there is no historical documentation that specifically mentions this. The garage with attached dwelling may have been constructed later in the decade to provide housing for workers at the Patuxent Naval Air Station.

The residence (currently vacant) on the west side of Three Notch Road (MD 235) north of Hewitt Road is located approximately 75 feet west of the road in an area characterized by mixed residential and commercial uses. Several mature trees and shrubs surround the house and a one-story concrete block garage and attached dwelling are situated west of the main dwelling. A gravel driveway runs along the north side of the property.

The 1.5-story rectangular unpainted cinder block building has a block foundation. The house has an asphalt shingle gable roof that flares at the base of the east slope. A small shed-roof dormer is located on the east slope and a full-width shed-roof dormer is located on the west slope of the roof. A one-story flat-roof enclosed porch extends from the south side of the dwelling and a shed-roof entry porch and small shed are appended to the west elevation. A brick stringcourse encircles the house between the upper and lower stories. A brick chimney rises through the center ridge of the roof. Windows throughout the house consist of multi-pane metal casement sash with brick sills on the first story.

The east, or main, elevation contains a central inset entry flanked on the north by a multi-light metal casement window and on the south by a tripartite picture window with center fixed sash and eight-light casements. A brick railing is attached to the north corner of the entry. Two sets of paired six-light casement windows are located in the shed-roof dormer in the east elevation. The north elevation includes three bays in the first story: a door in the west end and two eight-light casement windows. A set of paired six-light casement windows is located in the gable. The first story of the west elevation contains three casement windows and an entry protected by a shed-roof porch with a small frame shed attached to the north side. The dormer includes a large casement window. The first story of the south elevation includes an enclosed porch with perforated cinder block walls topped by frame window openings (currently empty but may have been screened) with brick sills. A door is located in the west side of the porch. Single metal casement windows flank either side of the enclosed porch. A door with half-height sidelights is located in the gable end and provides access onto the porch roof.

An ell-shaped painted block garage with attached dwelling is situated west of the main dwelling. The two-car garage portion of the building has a cross-gable asphalt shingle roof and is located at the southern end of the building. The east elevation of the dwelling portion includes a door near the junction with the garage and a set of paired windows is located at the north end of this elevation. The north elevation contains a central door.




The Lanham House was most likely built *circa* 1940 and displays influences of the Craftsman/Bungalow style with its flared roof and shed dormers, however, the use of unpainted cinder block and metal casement windows is somewhat unusual. The Lanham House may have been associated with an agricultural parcel, however, there is no historical documentation that specifically mentions this. The garage with attached dwelling may have been constructed later in the decade to provide housing for workers at the newly established Patuxent Naval Air Station.

Prior to the establishment of the Patuxent Naval Air Station (NAS) in 1942, the county's economy was primarily based upon agriculture (tobacco) and fishing, and very little modern development was evident in this portion of the state. In 1940, the population of the Bay district was 1,287; by 1950 it had increased nearly five-fold to 10,575 (Hammett 1991:491). The tremendous influx of workers employed by the NAS resulted in extensive residential and commercial development along the Three Notch Road (MD 235) corridor.

It is unlikely that historic or prehistoric archeological resources are preserved on this property. The extensive disturbance typically associated with construction during the last 50 years is likely to have displaced any archeological resources that may have been on this property. Similarly, commercial and residential development in the vicinity make the survival of archeological resources on adjacent properties unlikely.

Historical documentation does not indicate that this resource is associated with Criterion A, broad patterns of history or a significant event or Criterion B, an important person who contributed to local or state history. The property does not embody distinctive characteristics of a type, period, or method of construction nor does it represent the work of a master or possess high artistic value; therefore, Criterion C, architecture, does not apply. Lastly, the property is unlikely to yield information which contributes to our understanding of human history. As a result of recent modern development in the immediate area, the property lacks integrity of association, feeling and setting. Despite minor alterations, as well as its poor condition and lack of maintenance, the dwelling appears to retain integrity of design, materials, workmanship and location.



 Resource Sketch Map


