Located just to the northeast of the Cardinal Gibbons Institute Memorial (SM-729) stands the only building remaining from the once prestigious school.

The Boys Dormitory, built just after 1924, is a low, one story, masonry building situated near the intersection of Seaside View and St. Peter Claver Roads.

Erected to house male students who resided too far to be bused to school, the dormitory played a critical role in the mission of the Cardinal Gibbins Institute to educate African Americans through a curriculum that stressed academic, as well as agricultural and industrial subjects. Although a majority of students were from southern St. Mary's County, some students came from other jurisdictions in Southern Maryland.

Further historical research and fieldwork is recommended to document this resource at a more intensive level.

The Cardinal Gibbons Institute Boys Dormitory is located approximately ¼ mile southwest of the intersection of St. Peter Claver and Seaside View Roads. Surrounded by a grassy field, the building is just north of the Cardinal Gibbons Institute Memorial and the county recreational park. The building is oriented on an northwest/southeast axis and is accessed via a short dirt drive that extends off of Seaside View Road.

Constructed after 1924, the Boys Dormitory building is a one story, three part, masonry building with a gable roof with hipped ends. The roof, pierced by an interior end chimney, is clad with asphalt shingles. The massing of the building is clearly divided into three parts. The larger central block is distinguished by a higher gable roof and exterior walls that project from the two side wings. Each of the wings is smaller in size and dimension and also exhibit hipped roof ends on the southeast and northwest sides. Portions of the gable ends are visible and are louvered. The building appears to be entered from doors located on the northwest and southeast sides. The door on the southeast side is flanked to either side by a one-over-one, double-hung sash window with louvered shutters (all of the windows feature similar shutters). The northeast side is divided into three parts. The central block is pierced by two central, one-over-one windows of larger dimension which are accompanied by two smaller one-over-one windows. Both of the wings are pierced by four one-over-one windows. A bulkhead entry into a basement is visible on this elevation, as is the interior end chimney.

The other elevations were not investigated.




