Very few remaining dwellings in St. Mary's County retain exterior sheathings that consist of wood butt shingles. Constructed circa 1900, the Adams house is one such example. Although now dilapidated and overgrown by shrubs and vines, this two story, three bay, single-pile dwelling with a two story rear ell represents a rare surviving example of a shingled exterior. Interestingly, the house's primary elevation faces south towards Drayden Road and not towards the Flat Iron Road. All evidence of the dirt drive from Drayden Road have been removed, thus diminishing the house's original relationship with the surrounding agricultural landscape.

Located on the east side of a slight bend in Flat Iron Road is the Adams House. Oriented on a north/south axis, the now overgrown property consists of three acres. The tract is bounded by residential lots to the north, east, and south while Flat Iron Road creates the west boundary. The parcel is topographically flat and the house is currently vacant and deteriorating.

The Adams House is a two story, three bay, frame house with a two story rear ell. Constructed circa 1900, the house has largely lost its historically agricultural setting as the lot is currently overgrown obscuring much of the house's architectural details. Judging from the east and south elevations, the house's exterior walls are sheathed with wood butt shingles, while the gable roof is clad with asphalt shingles. The roof is pierced by at least two corbelled chimney flues that extend from both the main block and rear ell. Window types range from one-over-one double-hung sash to six-over-six double-hung sash. Some windows still feature their original louvered shutters.

Due to the overgrown nature of the property only a limited analysis of the overall building form could be conducted. The most visible elevations were the east, south, and north.
