The Quade House, situated at 39125 Maycroft Road, is located in the rural community of Oakley, Maryland. Situated down a long dirt farm lane, the house is oriented on a north/south axis with the south elevation commanding an excellent perspective of Miley Creek. Contributing resource include the main house as well as a row of agricultural buildings that extend to the west of the farm lane. These buildings include a stripping shed, corn crib, and two tobacco barns. The property, consisting of approximately 144 acres of which approximately 50 acres was surveyed, is bounded by wooded and agricultural tracts to the east and west, Miley Creek to the south, and Maycroft Road to the north.

The house itself is a two-story frame house that may date from circa 1850-1900. The house is clad with clapboard while the gable roof is covered with asphalt shingles. While much of the front or north elevation is obscured by foliage, the first floor contains at least three doorways accompanied by several windows. Some of these bays are shaded by a porch that extends over much of the front elevation. The second floor is fenestrated by several windows.

Due to the number of door entries as well as information collected from Steve Quade, the son of the present occupants, the house was constructed over at least two and maybe three periods. Further architectural investigations should determine exact construction date.


