Located at the southern tip of a peninsula surrounded by Combs Creek, Breton Bay, St. Williams Creek, and ultimately the Potomac River, Shorty's Shack is a two story, wood weatherboard covered dwelling that probably has important associations with local maritime history. Situated near the waterside community that grew up around the Combs Creek Marine Railway (SM-816), the circa 1900 house has unfortunately received a number of unsympathetic alterations thus diminishing its integrity. Architectural investigations should confirm the date of the building and oral history should uncover the maritime background of the building, otherwise no further documentation is recommended.

Commanding expansive views of the mouth of Breton Bay and the Potomac River, Shorty's Shack is located at 21540 Joe Hazel Road near the rural crossroads community of Compton, Maryland. Situated at the southern tip of a peninsula, the house is oriented on a south/north axis and lies on a broad flat turn-around at the terminus of Joe Hazel Road. The 1.59 acre lot is bounded by water on the east, south, and west sides and by a residential lot to the north. These bodies of water include St. Williams Creek, Combs Creek, Breton Bay and ultimately the Potomac River.

The house, constructed circa 1900, is a two story, five bay, single pile, dwelling with a gable roof and a rear two story kitchen ell. The exterior walls are entirely sheathed with clapboard and the roof is clad with raised-seam metal. The roof is pierced by two interior brick chimney flues and on exterior end chimney located on the house's north side.

The fenestration of the primary or south elevation has been altered since its initial construction. The first floor is pierced by two doors and two one-over-one, double-hung sash windows which are shaded by a porch supported by square posts interspersed by plain square balusters. The east side of the porch has been enclosed and is pierced by a paired set of one-over-one windows. The second floor of the elevation features four one-over-one windows.

The east elevation is comprised of a confusing array of additions to the dwelling. The enclosed portion of the front porch is lit by single window. The gable end of the main block has a one-over-one window on the first and second floors. An addition to the rear is pierced on the first floor by a central door flanked on either side by a one-over-one window. The second floor of the rear ell is distinguished by one window. A shallow pitched shed addition to the north of the rear ell is entered through a single doorway.

No other elevations were investigated.


