Carriage barns represent a relatively rare building type found in the county. A specialized building to house the family carriage, a supply of hay, and perhaps trotters as well, the carriage barn was often situated close to the main house and usually received architectural decoration. Although certainly not as elaborate as the carriage house at Jutland Farm (SM-627), the scroll sawn vergeboard at the circa 1890 Little Hackley Carriage Barn indicates the late-nineteenth century property owners paid attention to the appearance of their outbuildings in addition to their main domicile. Unfortunately, the main house burned in 1999. Nonetheless, several of the farm's outbuildings remain and should be documented in the winter when the foliage is not as dense.

The Little Hackley Carriage Barn, located on a remote farmstead near Avenue, Maryland, is oriented on a northwest/southeast axis. The barn is located just south of the house which recently burned. Several other contributing buildings and a tenant house are strewn about the immediate vicinity but were not documented due to overgrowth at the time of the site visit. They are nonetheless worthy of further documentation. The farm itself consists of 107 acres consisting largely of cultivated fields of which only one acre immediately around the carriage barn was surveyed. The main farm access is down an impressively long lane that extends to the southwest of Colton's Point Road. Lined by trees, the road lies directly on axis with the now burned house. The farm is bounded by residential lots to the north, Colton's Point Road to the east, a small marsh to the south, and St. Catherine's Sound to the west.

The Carriage Barn is a circa 1890, one story, gable-front, axial plan, frame building with a gable roof. The exterior is clad with horizontal, wood weatherboard. The roof is covered with raised-seam metal. A small scroll sawn vergeboard is visible on each of the gable ends and cross gables.

The primary or northwest elevation consists of a large carriage entry. It appears the doors of the building are not longer extant. No other windows are visible.

No other elevations were investigated.


