Despite being overgrown by shrubs and trees, the Tobacco Barn on Ryceville Road is an agricultural building whose exterior walls are sheathed with vertical boards and roof is covered with raised-seam metal. While the overgrowth hinders even a cursory exterior analysis of the building, the steep roof pitch visible on the barn's west-side suggests the barn probably dates from the last quarter of the nineteenth century (1875-1900). At least two other agricultural buildings line the present farm road that leads to a non-contributing modern dwelling. Further architectural analysis is necessary to properly date the building.

The Tobacco Barn on Ryceville Road is situated on the north side of the road near the rural crossroads community of Thompsons Corner, Maryland. The barn is oriented on south/north axis and is approached via a road that extends to the north of Ryceville Road. At least two contributing outbuildings in addition to the barn line the drive that leads to a noncontributing modern house. The barn is surrounded by a 19.47 acre tract of which only about 10 acres was visible from the road. The property is bounded to the east, north, and west by agricultural tracts and to the south by Ryceville Road.

The Tobacco Barn on Ryceville Road probably dates from the last quarter of the nineteenth century (1875-1900). The exterior is sheathed with vertical boards and the roof is covered with raised-seam metal. Due to significant overgrowth much of the building is obscured from view. Sheds, however, are clearly visible on the barn's west and south elevations. It also appears that the barn followed a north/south axial plan. Further proof, namely the steep pitch of the roof, suggests the barn may predate the Civil War. In order to determine the exact date, further architectural investigations are necessary.
