DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Hedrick Farm is an early 19th century brick farmhouse located between the village of Matthews and Kingston Landing. It is composed of a three bay long, two and one-half story section with a lower one and one-half story portion five bays long, all of which is only one room deep.

The southwest facade of the building is laid in Flemish bond, whereas, the other sides are laid in common bond. There is neither watertable nor belt course, however, there is a two brick corbeled cornice on the lower wing. A portion of the southeast end has been relaid with new brick, probably the result of deterioration due to the constant heat of the kitchen fireplace.

In the main portion of the dwelling the first story windows have 9/6 sash on the first story with louvered shutters beneath the one story porch and none elsewhere. 6/6 sash are used in all other windows including the two dormers on each side of each section. A chimney pierces the 'A' roof at the northwest gable and in the center of the wing. There is also a small new chimney on the new southeast gable. The main entrance is located on the easternmost bay of the main portion. In addition, there are also entrances into the two parts of the wing.

The floorplan consists of a living room and stair hall in the main part with dining room, bath and kitchen in the wing. Almost identical plans are found on the second story. Most of the interior trim is original in all but the kitchen section. The living room is lighted, like many houses of the period, by six windows. The mantel has very good proportions with pilasters of herring bone reeding. There are no paneled jambs to the windows which have good three-part trim. The chair rail is two piece and simple. The stair hall has a simple stair with delicate balustrade, having two rectangular balusters per step and paneled soffit.

Located two or three steps lower, the dining room has heavier chair rail and paneled cupboards flanking the fireplace. The window jambs are also paneled.

On the second story the trim is simpler than the first story. A small room is located at the head of the stair and the dining room chamber is divided into two separate compartments, one with a fireplace. Most of the hardware throughout has been replaced.

The attic has also been divided into two compartments which were originally plastered. A cellar under the main part has been partially filled with rubble and dirt due to excessive moisture in the area.

On the property are two small outbuildings, one appearing to be a smokehouse, the other a 20th century pump house.


