DESCRIPTION OF PROPERTY AND ELIGIBILITY DETERMINATION:

Summary Description:

The Edward Rose House is located on the south side of Queen Anne Highway (MD 404), between Newtown and Dulin Roads, in Talbot County on Maryland's Eastern Shore. The house sits near the highway on a 47-acre parcel that is currently farmed. A meathouse and garage are the only outbuildings associated with this property. Constructed circa 1920, the residence has a T-plan consisting of a two-and-a-half-story main block with an equally tall rear kitchen ell. One-story additions have been added to each side of the rear ell (screened porch on east side). These additions are on poured concrete foundations and appear to be historic. The dwelling is vernacular with subtle ornamentation such as central cross-gables on both the façade and the eastern elevation of the rear kitchen ell and the patterned shingles and arched windows in all the end gables. It is covered with aluminum siding, has an asphalt-shingle roof, and sits on a brick foundation. Windows are original two-over-two sash with replacement one-over-one sash on the first story. A gabled-roof entry porch on the five-bay façade is a recent addition. The meathouse sits directly to the rear of the residence. It is a small frame structure with a corrugated-metal-covered gabled roof, a rough concrete foundation, and vertical plank siding. The frame garage has a metal roof.

Significance:

The Edward Rose House does not retain sufficient architectural or historical integrity to be recommended eligible for listing in the National Register of Historic Places under any criteria. Modifications such as the siding, front entry porch, and replacement windows have changed the historic appearance of the structure. Domestic outbuildings are few and any agricultural buildings that may have been present are gone. While this property has not been dramatically altered, it does not possess significant architectural importance in either construction or detailing to be eligible for listing. In addition, its relatively late (early twentieth-century) construction date is not representative of the period of heaviest development along this portion of highway, which took place 50 years earlier.






Resource Sketch Map





