DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Saulsbury is located east of Trappe south of the Miles Creek. It is composed of two sections, a tall brick, three story dwelling with small frame wing on its east side. The brick section is unique in the county with the gable of the gambrel roof house being the principal facade. The walls are laid in Flemish bond above the water table and English below. There are two basement windows on the south facade. The fenestration is assymetrical with two large windows flanking a middle door. There are segmental arches above the windows, but none over the door. Three windows smaller than below light the second story and two windows in the third story or attic. All windows but the third floor have 2/2 sash. A course of stretchers extends between the first and second storys. The north side has only two windows on the first and second storys and a basement entrance on the west.

There is only one window on the west side, the roof begining at the second floor level and extending to the third in a steep pitch and from thence in a lesser pitch to the apex where a broad chimney rises from the roof, near the rear of the building. On the east the house joins with the 19th century kitchen.

Inside, the plan of Saulsbury is unique in Talbot. It has a central vestibule with stair against the central chimney. On each side is a single room, both with fireplaces and partitioned from the vestibule by rised paneling with the raised part of the panels in the vestibule and the plain recessed panels in the two rooms. Over the living room fireplace is a bold raised panel with bolection molding. A large bolection molding surrounds the fireplace. The dining room has a similar treatment, however, the room is smaller and the treatment plainer. There is an original batten door hung on unusual strape hinges with unusual two pronged plate.

On the second story is the same two room plan but in place of the fireplace, like the living room chamber, the dining room chamber has a closet behind the board wall. The third story is a simple room with portion partitioned off above the aforementioned closet.

STATEMENT OF SIGNIFICANCE

Saulsbury is a unique specimen~~s~~ of mid-18th century vernacular architecture in Talbot County. Its floor plan was similar to the original plan of Carvill Hall, Kent County and possibly like the original Martingham. The form of the structure is unusual and intriguing. Its interior woodwork is quite good, but the fact that the raised panels are in the vestibule rather than the room is cause for bewilderment. In all, the building is a unique structure which should be preserved because of those qualities.




