DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house began as a late 18th century hall and parlor, one story dwelling with an exterior chimney at each of its north and south gable ends. The one room, one story kitchen at the north end once had a gable roof, but it now has a flat deck roof enclosed by a railing. This kitchen was an early addition to the main house but it has been greatly altered.

In the north room a boxed stair stands in the northeast corner. The adjacent fireplace features an original mantelpiece with ogee and cyma recta moldings. This room is lit by two 2/2 sash windows on the east and one window on the west, which has a simple ovolo architrave. The south room has one door to the east and another door, with sidelights, to the west. There is a cellar under the house which has an exterior entrance on the east side. The roof has two dormers on either side. A recent porch runs across the west side of the south room.

A mid-19th century frame addition runs perpendicular to the original house at its south end. This two story section had two rooms on each floor. The boxed stair has a fine chamfered newel post topped by a cap with a cavetto-astragal molding.

STATEMENT OF SIGNIFICANCE

"Hole-in-the-Wall" is a small frame house which apparently dates from the late 18th century and later. In its present form, which whatever is visible inside and out, it appears to be representative of vernacular structures of the period. Tradition maintains that the building is possibly 17th century in date, but this seems unlikely. Future research will be necessary to establish the historical importance of the building.


