DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

As of this writing, Howell's Point house is no longer standing, it having been demolished by the new owner of the property who also demolished Crosiadore in '76.

Howell's Point was built around 1920 in Georgian Revival style, a large frame, hip roof house with extensive auxiliary building of the same period. The approach facade is divided into five massings, a central rectangle with hip roof with flanking wings having cornice and height continuous with the central part but set back from the main facade. At the outer ends are one story flat roof porches with balustrade around the roofs.

The main facade had an entrance with sidelights and a small portico, above which are two windows with 12/1 sash and louvered shutters. West of the door are two windows on the first story and one above. East of the door are irregular windows reflecting the position of the stair. Two hip roof dormers with two casements each pierce the roof. At the west end of the hip roof structure rises a chimney which pierces the wing roof.

The west wing has two windows below and three openings above which appear to be an enclosed porch. The first story porch has arched openings.

On the east is irregular fenestration, also suggesting a stair and service useage, i.e. kitchen, pantry, etc. A large chimney rises from the east end of the building and there is a dormer on its roof. The east porch is enclosed.

Facing the water its facade is more regular with essentially a six bay main part with three bay east wing and two bay west wing. Across the first story of the main part is a screened porch with balustrade on the flat roof, like the flanking porches. There are 12/1 sash throughout but the first story shutters are paneled and the second story louvered.

East of the mansion was a three car garage with quarters above and an overseers cottage. Southeast was a garden.

STATEMENT OF SIGNIFICANCE

Howell's Point was one of the finer Georgian Revival style dwellings in Talbot County. Its demolition was a loss to the county since it had very fine wood details and was in good repair. The interior, from what was available from looking in the entrance door was very well appointed with paneling, Corinthian pilasters and a superior stair.

It is also the site of much earlier habitation both historic and aboriginal.
