DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Anderton is a handsome frame vernacular structure similar to several of the Dorchester County dwellings of the eighteenth and nineteenth centuries. It is composed of two portions, a five bay long one and one-half story part and a three bay long two and one-half story part. The latter part is reputed to have been built around 1878 for Mr. Alexander Stewart. It follows the general plan of vernacular dwellings of that period, being one room deep and two rooms long with enclosed stair between. On the back side of this wing is a jalousie porch.

The earlier one and one-half story portion stands upon a low brick foundation and there is no basement. The wall of the three bays consisting of the central entrance and two windows nearest the latter addition are covered with beaded shiplap whereas the other two bays are sheathed with beaded weatherboard. There is a covered porch supported on chamfered posts over the entrance with its side-lights. Three dormers on the front slope of the roof light the chambers above. All of the windows have 6/6 sash except two on the assymetrical gable.

The division in the siding has a similar division inside, in that the flooring material and trim differ in the two corresponding parts. Yellow pine flooring is seen in the shiplap part and white pine in the weatherboarded part. There are several early four-panel doors in the shiplap part and later style doors and trim in the weatherboard part.

The weatherboarded portion of the house is two rooms deep, the back room having a very low back wall with 4' door. The woodwork of this part all appears to date from the second quarter of the nineteenth century.

The stair enclosed in the central hall is in the older part of the house and was installed there when the house was extended. Probably the original stair was enclosed adjacent the fireplace in the dining room. This portion of the dwelling also has an assymetrical roof which is not noticeable because of the additions on both sides. It resembles the roof at Boston Cliff on the Choptank, although there are dormers on both sides of Anderton. The variation in pitch is easily visible in the dining room chamber ceiling. In form, floor-plan and development, Anderton closely resembles Covey Landing house in the upper part of the county.

STATEMENT OF SIGNIFICANCE

Anderton's architectural importance lies in the fact that it represents the steady growth of a vernacular structure, retaining most of the original work of each period, spanning the period between c.1740 - 1880 with modern conveniences added in the twentieth century. Its growth and resultant form resembles the aforesaid Covey Landing and Bounds Lott, Wicomico County
