**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

Deep Water Point defies stylistic classification. It is a 1926 dream house with overtones of a medieval castle.

The building is essentially a rectangular 'A' roof, one and one-half story brick structure with applied pavillions, towers, gables, turrets and arcades. It is laid out with a garage/guest house southeast of the house and connected by a wall. The kitchen, built in 1935 is also on the south end and is set behind the aforementioned wall, thus leaving the service area in its own place.

The main body of the house is flanked by two large round towers with gable pavillions between them and the main body, creating in one image an impression of mass and of a small building. The walls are laid in common bond brick and the turrets have arched corbel tables and corbeled cornices. The irregular windows have steel casements, some with stain glass. Across the east facade is a broad three centered arch entrance. On the opposite wall is a porch of five arches now glazed with sliding doors.
