DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Harleight situated on Trippe Creek appears to be a 1930 Georgian revival style mansion typical of the houses of the day built for the wealthy of Talbot County. On closer examination, however, the house does possess a portion of an early structure. Only by examining the basement can the puzzle be solved for there the old brick foundation walls are clearly differentiated from the newer walls.

On the approach facade, the house is a long five bay, two and one-half story hip roof brick dwelling with deck atop the roof. Approximately in center of the roof rise two brick chimneys. On the south is a brick wing containing kitchen and other service rooms.

The floor plan consists of a central corridor with two flanking rooms. The room on the south is not as deep as the opposite for behind that room is an open stair in its own side hall. In both of the rooms the fireplaces are on the corridor walls. The stair ascends along the west facade, across one window to a landing and thence to the second story. The stair landing is located just over half the depth of its joining room. Beneath this point and in a corresponding location beneath the north room are the ends of the original brick foundation. Originally therefore the house was as deep as it is now but only about half as long, that is three of the five bays of the facade.

The stair has tapered balusters and a mahogany newel and rail. Original six panel doors and trim with corner blocks exist in the corridor area at least of the first story.

The configuration of the roof is not known, however, there will be photos to come to light as the remodeling occurred very recently.

A mantel within was saved from Belleville, a Federal period dwelling which formerly existed across the road from Harleigh.

STATEMENT OF SIGNIFICANCE

Harliegh is significant as a mid-19th century dwelling possessing a good stair and trim original to the period. It is of interest in that it depicts a style of dwelling so popular in the 1920's and 30's in Talbot.

Its early mantel is of interest as the only remnant of the dwelling in which lived members of the Kerr family.
