DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

On a small peninsula of Goldsborough Neck, overlooking the upper reaches of the Miles River stands Ashby, a Goldsborough house built in 1858. The house stands on the highest point facing south, with the lawn rolling gently down to the River with a two mile vista down river.

Being built in 1858, the house has many features of other Italianate dwellings in Talbot County. The core of the Italianate house is two bays wide and three bays deep with a two bay long extension to the east rear. Still further east is a hyphen and kitchen, part of which is one story and part two story. South of the aforementioned extension adjoining the main body of the house is a one story semi-ocagonal room. On the west side of the main block is a two story porch with pierced splat balustrade. Its south side is enclosed as is the entire first story.

To this, mostly original, house has been appended a Colonial Revival portico on the south facade a one story porch on the north and a bay window on the north side of the extension (1941).

The building is constructed upon a brick foundation (reputedly part of an earlier foundation) and the framed walls are covered with German siding. On the west side of the facade is a bay window with 6/9 sash and a bracketed cornice. There is a window and door on the east side of the facade. Only two windows are located on the second story. The adjoining semi-octagonal wing has a plain cornice which suggests a later date. East of the house extends a fence with tall shrubbery seperating the facade from the service area.

On the west side of the house are the aforementioned porches but there is also a gable in the 'A' roof having two small semi-circular arched windows, flanked by two tall chimneys, similar to Cherry Grove near Trappe. The north porch extends west of the other porches and although built in 1941, has the same detail as the original. The north gable end has two windows on each story.

The east extension has original bracketed cornice as well as two dormers. Extending in a north-south direction east of the extension and hyphen is the frame kitchen, the north portion of which is two storys with shallow pitched hip roof, the other having a shallow pitched 'A' roof.

North of the house and kitchen are the Goldsborough Cemetery enclosed by a brick wall and a long Williamsburg copy guest house with a formal box garden between the two. North of the above, the land extends to a high bank of the Miles River.

STATEMENT OF SIGNIFICANCE

Architecturally Ashby is significant as a unique Italianate dwelling in Talbot County. The other Italianate dwellings in Talbot, i.e. Cherry Grove, Ingleside, Old Villa, were essentially symmetrical, almost self contained Georgian blocks, but Ashby was designed mor toward the view of the River and the prevailing breezes. It is more romantic in feeling than the others mentioned above. The addition of the present portico in 1941 is a curious attempt to create a formal Georgian mansion out of the otherwise informal Italianate dwelling.

The service wing is a curious and unique survival as is the separation of the front from the service area. From the stand-point of landscape, Ashby is laid out in a natural informal manner to make best use of the views and terrain.

Behind the house, the Goldsborough Cemetery is a significant 19th century private burrial ground, similar to Gross Coate and to a lesser degree to Wye House.


