DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This elegant frame house built in the mid-nineteenth century is composed of three three-story elements. The most prominent is the northern block, side hall and single parlor in plan. A widow's walk tops the bracketed pyramid roof. Flat roofed porches supported by ionic columns and pilasters rising two stories uninterrupted run along the north, east, and eastern portion of the south sides. The fireplace on the north parlor wall features a fine reeded mantel with ogee cornice. The chair rail in the parlor and hall is also reeded. There is a heavy carved newel post at the foot of the stair. A panel fills each space between the window and baseboard. The architraves have Greek ovolo moldings. The door at either end of the hall has a transom and sidelights. There are two bedrooms with fireplaces over the parlor.

The middle section of the house has two rooms, with a fireplace on the south wall of the north room and a winding stair on the south wall of the south room. Each room has an exterior door. A two story addition on the west end of the north room extends in an open porch across the west hall door of the main block.

The last section has a bracketed gable roof running east-west perpendicular to the rest of the house. The west room has a winding stair in the northeast corner and a recent one story addition along the west wall and the west end of the south wall. The east room has a fireplace in the south wall, a three story bay window on the southeast corner, and a one story glassed porch on the east.

Most of the windows hold 6/6 sash windows. The house is sheathed in clapboards.

STATEMENT OF SIGNIFICANCE

North Bend probably began life early in the 19th century as a typical Federal farmhouse. It may have been similar to Perry Hall built about the same period. It is a unique structure in Talbot and a curious and not very successful attempt to remodel and enlarge an earlier house. Many of its features from each period of remodeling are good examples of craftsmanship.


