DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house began as a mid-19th century one story frame dwelling with a single interior chimney at either end. Two surviving mantels on the second floor feature Greek ovolo moldings. The present floor plan of a central stair hall with a room on either side may be original, although the stair was probably changed.

Between the late 19th century and the present, Halcyon was raised to two storys, the fenestration completely changed, a two story porch was added to the north side, and large two story wings were added to the east and west. The house was renovated by Harry Campbell in 1954. In 1972 Thomas Raugh repaired the house and renovated the nearby late 19th century tenant house.

STATEMENT OF SIGNIFICANCE

From an historical architectural viewpoint, Halcyon is one of the few buildings to have retained no evidence of its early form. Only the chimneys indicated the approximate ends of the original one and one-half story dwelling. Its present appearance is far more important than what it was originally although its additions are relatively simple and non-stylish. It is largely the result of 20th century remodeling.
