Forming a picturesque group along South Street, these three Victorian Gothic cottages of brick are outstanding in a neighborhood in which small frame houses predominate. The corner house, 120 South Street is the largest. With its very steeply pitched gable roof and triangular, louvered inserts above second floor windows, this house bears some resemblance to Christ Church Rectory (T-15) designed by Richard Upjohn in 1852. The designer of these three two-story structures is, however, uncertain.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This small brick house is the most elaborate of the three Victorian Gothic cottages which stand at South and Hanson Streets. It is two bays wide and twenty feet deep with a steeply pitched gable roof facing the street. The roof has widely overhanging eaves supported by shaped rafters. Triangular arched window openings have six over six sashes secured by simple, narrow frames. The triangular portion above the sash is filled with wooden louvers. The small attic window is treated similarly, but closed with louvered shutters. Side wall windows, irregularly spaced have six over six sashes and plain wooden lintels.

The eaves are interrupted by two gable dormers in each side wall which extend below the roof line, making this a one-and-a-half story house with a supra attic.

Main entrance is in the western bay. Typical of its period it has an overlight and sidelights with lower panels. The door itself has four panels edged with simple moldings.

A one-story porch is used on the front of the structure. Square, chamfered posts and curved ornamental brackets support the low hipped roof. A similar porch once stood on the east wall.

The stair is of the dog-leg type but with winders. Step brackets and a heavy round newel are primary ornaments. Windows and doors are treated with flat, unmolded frames. The dwelling is of the side hall type with a rear room which runs the full width of the house, behind the stair. One mantle remains: it has a shelf and rectangular opening edged with moldings.

At the rear are two brick wings which appear to be contemporary with the main house. The larger of the two is directly behind the main house; the other, set to the side of the first addition, forms a court between this house and #118 Goldsborough. In detailing and construction these wings are very similar to the main house.

The structure has been divided into apartments and single rooms. It has been neglected and seriously in need of repair.

SPECIFIC DATES Mid Nineteenth Century BUILDER/ARCHITECT Annie R. and Richard Trippe

STATEMENT OF SIGNIFICANCE

The house is significant for its architecture. Its picturesque roof and Victorian Gothic detailing contribute to the great variety of nineteenth century building in the town. The three cottages are quite compatible with the frame structures on the street, contributing a richness which makes this one of the most interesting - if modest - blocks in the town.*

The cottages have been attributed to Richard Upjohn, the well-known nineteenth century architect who designed the Christ Church Rectory (T-15) and the Trippe-Beale House (T-45) both on South Street. This attribution has not been thoroughly investigated. Window and dormer treatment, as well as roof configuration, do resemble that of the Christ Church Rectory. The modesty of these structures would lend a certain question that an architect of Mr. Upjohn's standing would have been able to accept such a small commission.

L79/F93 In 1873, Annie R. Trippe, the wife of Richard J. Trippe, bought the lot at the southwest corner of South and Hanson Streets for \$200.00 from William Bostwick and his wife. In 1908, as a widow, Mrs. Trippe sold her house and property to L152/F473 Cora Leonard for \$1400.00. Cora L. Leonard sold the property L160/F423 to Sallie Virginia Marvel in 1919 for \$2000.00. The Marvel L263/F161 heirs sold it to Esta May Harrison who sold it to the present owner in 1962 for \$2500.00, Edward A. Webb.

* Other noticeable modest dwellings here are #111, 113, and 115 (T-460) and the Easton Art Academy (T-19) at the corner of South and Harrison. The structures on the north side of the street are threatened with demolition by the town. It would be an unfortunate loss, disrupting the unity and integrity of the street.






