Mount Misery was originally surveyed by Michael Bourne of the Maryland Historical Trust in 1977. For additional information please reference this original survey form (T-207). According to Malcolm Ringel, the current owner of Mount Misery, few changes have been made to the exterior of the dwelling since he purchased the house in 1995¹. Most notable is the re-roofing of the main block and kitchen with wooden shingles during the summer of 1998.

The property is an irregularly shaped parcel, and the house is offset from the road by a gravel drive lined with trees, obscuring its view. A 1954 kitchen renovation is noted in Mr. Bourne's form. A breezeway, garage, and stable may also have been added at this time, but these buildings are not identified in the 1977 survey form.

The one-and-one-half-story kitchen addition extends from the north elevation of the main block. A breezeway connects the kitchen and a two car garage. A salt-box roof covers living space on the second story of the garage. Connected to the north of the garage is a one-story, three bay stable and guest room. A sunroom and arbor on the west elevation of the kitchen addition appear to have replaced an earlier enclosed shed roofed addition. Adjacent to the south elevation of the main block is an in-ground swimming pool. A garden house/pool house "connects" the pool area to an enclosed garden. This small building has entrances on both its pool and garden elevations. Several modern columnar structures, functioning as gazebos and arbors, are located throughout the property. A sunken volleyball court is southwest of the house. No interior access to the house was permitted; however, Mr. Ringel reviewed the 1977 MHT form and did not see any discrepancies.

Although the house is well kept, there have been many alterations to the property during the second half of the twentieth century. The additions of a kitchen, garage, stable, and guest house attached to the main house by a breezeway, have significantly altered the form of the house. The original parcel of Mt. Misery has been subdivided, and the setting is infringed upon by several neighboring properties. The in-ground swimming pool and modern arbors also detract from the historic association of the house. The integrity of Mount Misery (especially design, setting, feeling, and association) has been compromised by the amount of new construction and property subdivision. For these reasons Mount Misery is recommended not eligible for listing in the National Register of Historic Places under Criterion C.

A breezeway connects a garage and stable to the northwest corner of the kitchen addition. Modern additions include a garden/pool house, garden, and in-ground swimming pool.

Verbal boundary description and justification

The parcel of land originally consisting of Mount Misery been subdivided through the years. The agricultural fields surrounding the main house are no longer part of the parcel. The lot adjacent to the house have been developed. The lot Mount Misery is on had also had several modifications such as a swimming pool and large addition on the north elevation. For these reasons, the significant portion of Mount Misery has been determined to be only the footprint of the main block. However, the setting of the property includes all that acreage that is part of the entire tax parcel (Map 31, parcel 169). Therefore, the acreage of the verbal boundary is, an undetermined, smaller portion of the entire 4.42 acres consisting of the Mount Misery property. See attached maps.



DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Edward Covey bought this property in 1804 at a bankrupt sale. He probably built the brick house which now stands there. The two story, three bay house has a hall and parlor floor plan and an interior chimney at either end.

The south room has a door and 6/9 window in its east and west sides, while north room is lit by a 6/9 sash window in each of these walls. A door in the north wall leads into the modern replacement of the original brick kitchen.

On the west side of each fireplace a winding enclosed stair leads to the second floor. Between each chimney and stair stands a narrow closet. The upper and lower closet doors each contain two vertical panels. There are chair rails in both rooms. Simple but attractive mantels adorn each fireplace. The most common moldings include a cavetto and astragal and a cyma recta and astragal.

The east wall is built in a Flemish bond while the other three are 5:1 common bond. Jack arches are located above the windows and doors. A one story porch once ran along the northern two-thirds of the west side. On the second floor there are two 6/6 sash windows on the west side and three on the east side. The north and south gable ends each have two four-pane windows in the attic. There are two 6/6 sash dormer windows on each of the gable roof slopes.

STATEMENT OF SIGNIFICANCE

Mt. Misery is a well built early nineteenth century brick farm house comparable to Katlings Plain and others in Talbot County. It is curious that the "hall and parlor" plan was still in use into the 19th century. Its restoration undertaken by H. Chandlee Forman was well executed and the best features of the building have been preserved or reproduced.

Edward Covey reportedly replaced a frame house with the present brick house when he bought the property in 1804. It is said that he retained the brick kitchen from the earlier house, but this kitchen was rebuilt in the 1954 renovation of Mt. Misery.

On January 1, 1834 Frederick Douglas, the great abolitionist, was sent as a slave to an Edward Covey, known as the "slavebreaker" to be "broken."
