DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Fausleywood farmhouse is located at the head of Glebe Creek on Villa Road. The house is a three bay long, two story dwelling covered with aluminum siding. The two east bays of the building are frame and the one west bay is brick. Within each gable is a large brick chimney. Both parts have a common roof, but the west windows are smaller and higher than the east, reflecting the change in floor level within. On the rear of the dwelling is a two story addition and a leanto.

The building appears to have been constructed in the early 19th century, although it is not immediately apparent which section came first. A former door in the west gable of the house may have led to an early west wing prior to the construction of the east.

Its interior is divided into hall and two rooms with kitchen behind. In the brick west room which is 2 or 3 steps higher than the hall, a stair ascends in the southeast corner. It and the back entrance have doors with two panels and bolection chair rail between. (Possibly taken from Fausley, where Tench Tilghman was born.) The handsome Victorian painted slate mantel was taken from Woodstock, on the same neck of land

STATEMENT OF SIGNIFICANCE

Fausleywood is an interesting dwelling which has been put together from parts of an earlier dwelling. It is an early 19th century house which has grown throughout the century into a modest vernacular dwelling. It would be more significant from an architectural standpoint if the original walls were exposed and if the interior had not been so vastly modernized in recent years.


