DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The sculptor, Lee Laurie once lived in this early 20th century frame house. It is two storys high, five bays wide and two bays deep, with a gable roof running northeast-southwest. A one story addition projects perpendicular to the main block from its eastern end. The addition, once a kitchen and a garage, was recently modernized and rearranged. Its finished loft is lit by two windows in the gable end and a dormer in either roof slope.

The white shingled main house features a Colonial Revival enclosed entry. A fanlight tops the door, which is framed by double pilasters on either side. Double Greek ovolos head each ground floor window on the exterior. The frame architrave runs to the floor, framing a 6/6 sash window above a shallow rectangular panel set horizontally.

A large stair hall is centered between two parlors. The southwest room has a small, modern exterior fireplace on the southwest wall and a bay window on the southeast wall. A door and a window flank the fireplace, while two windows light the northwest wall. In the northeast room two windows light each of the exposed walls. The large open stair runs in three sections, turning 90° in each of two landings.
