DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The building is composed of a single volu~~m~~n with two bays across the front facade with an additional vestibule entrance. The foundation appears to be brick piers which have been filled in with bricks. The added vestibule, however, sits on a cinder block foundation. The corner stone states: "MacGee M.E. Church 1830 - renovated 1945 MacGee Memorial Methodist Church." The siding is asbestos siding. The windows have double hung sashes 6/6. The gable facade has a full pediment above the second story formed by the continuation of the cornice around both sides. A chimney rises between the two windows on the north side. The north elevation has a door. An addition has been added off the east end.

STATEMENT OF SIGNIFICANCE

MacGee M.E. Church is a fine small frame late Federal style chapel built in the 1830's and used until the present time. It is a unique chapel in Talbot but its form is common. The pedimented facade is frequently encountered on dwellings in Somerset and Worcester Counties.
