DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Kirby Wharf house is a fine frame dwelling with its southwest facade overlooking the Choptank River. The building is composed of three sections, a three bay, two story, hip roof central section with an old, two bay long, one and one-half story wing on the southeast and a 20th century, one and one-half story wing on the northwest. The central portion has a center door on both facades, the northeast having plain architrave, sidelights and transom. At the corners of the structure are pilasters extending to the modillion cornice. Each of the five windows of both storys have pairs of 4/4 sash windows and louvered shutters. A brick chimney rises within the narrow ends of the structure. Across the entire center facade on the river side is a hip roof screen porch.

Its early wing has an 'A' roof with leanto porch on the entrance side. Beneath the porch roof is a balustrade around the entrance to the cellar, a unique feature in the County. It has two doors with window between. On the roof are two small dormers (on each side) with 4/4 sash. Its river facade has been completely altered recently and has a bay window and series of three casements. On the outside of the gable is a brick fireplace and chimney typical of 19th century work in Talbot, Dorchester and Caroline Counties.

STATEMENT OF SIGNIFICANCE

Kirby Wharf is an architecturally significant dwelling because it represents cross between the Greek Revival and Italianate styles. It is a mid-century dwelling with a hip roof usually associated with houses of Georgian style. In that respect it resembles Ingleside, but is half the size. It retains many good original details of the 19th century.


