Pickwick, located at Little Neck Creek, a small tributary of the Miles River, is composed of a one-and-one-half-story, five-bay vernacular structure with a lean-to shed and frame kitchen to the north and a two-and-one-half-story, three-bay wing to the west. The interior detail in the long section dates to the second quarter of the nineteenth century; the wing appears to be from the third quarter of that century. The early section is raised on a brick foundation and covered with plain weatherboard. It has a central entrance shaded by a porch with a steeply pitched gable roof. Originally there were chimneys at both gable ends, but the east end's chimney disappeared. On the rear is the lean-to shed, and beyond this is the frame kitchen. Because of its size, the wing is now the principal part of the dwelling. It is covered with weatherboard like the early section and has a bracketed cornice. Outbuildings from the first period of house construction include a slave quarters and a dairy.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Pickwick is located on Little Neck Creek, a small tributary of the Miles River between Newcomb and St. Michaels. The farm is adjacent Maiden Point with which it has much in common.

It is composed of several sections consisting of a five bay long one and one-half story section with leanto back shed connected to an old kitchen with a tall, two and one-half story, three bay wide and two deep, frame addition on the west and a long run way to a one-time quarters.

The one and one-half story section appears to be the earliest part. It stands upon a brick foundation and is covered with plain weatherboard. The windows have 9/6 sash and louvered shutters on the first story and two dormers flanking a porch pediment, a later addition. There is a chimney on the west gable, but the east chimney has disappeared. To the rear is a shed across three of the five bays and beyond that, set at right angles to the house is a frame kitchen. Beyond the kitchen is a dairy which has been engulfed in the recently constructed run-way/guest quarters.

The west wing is really the principal part of the composition now. It has three windows on each story and two dormers in the attic, all with 6/6 sash. The weatherboard is like its earlier neighbor. Originally the first story, east bay was an entrance, but this has been relegated to the main pediment of the wing. There is a brick chimney painted white on the west gable.

Inside, the building has a typical two room and central stair hall plan in the old part and a stair hall and single living room in the large part. The living room was probably two smaller rooms as was the case with the dining room at Maiden Point, next door.

Much original detail remains throughout the two sections. Judging from the woodwork, the early part dates from the 1830-40 period and the tall extension from the 1860's. The kitchen and quarters, which closely resemble one another, also date from the earlier period.

STATEMENT OF SIGNIFICANCE

Pickwick is a significant dwelling of the second and third quarters of the 19th century. The first section is a vernacular structure with a few traces of the increasing popularity of "stock" interior detailing. Its addition is entirely the product of the machine age.

Pickwick is important for it retains original auxiliary buildings of the period including the kitchen, quarters and dairy.
