Birthplace of Lieutenant Colonel Tench Tilghman,
Christmas day 1744. Aid-de-Camp to General
George Washington, 1776-1783. And a participant
in every major campaign of the American Revolution.
He was entrusted to carry the news of the
surrender at Yorktown to the Continental
Congress in Philadelphia. Died, Baltimore April 18, 1786.

STATEMENT OF SIGNIFICANCE

Although nothing remains above grade, Fausley site is important as the birthplace of Tench Tilghman, Aide-de-Camp to George Washington during the Revolution. It evidently passed on to Tench for in 1798 his widow owned the 800 acre property.

In the Federal Direct Tax of 1798, Fausley is listed as a "one story brick dwelling 55 by 22 with two adjoining brick kitchens 22 x 19 and 22 x 17. There is also listed a brick study 22 by 17, wood smokehouse 15 by 14, brick quarter 40 by 18."

In 1783 James Tilghman is listed with "1 large brick dwelling house, kitchen affixed, 2 good tobacco houses, 10 small outhouses, 1 log dwelling house, kitchen, cornhouse, 1 barn, 2 small outhouses."

Possibly two doors from Fausley were used in the early 19th century dwelling now owned and occupied by Maurice Collins.
