DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Plugge Farm is located on Plugge Road east of U.S. Route 50. The house is a three bay long, two bay deep brick building with a two bay frame wing on the east and a frame tower in the center of the south facade.

Its walls are laid in Flemish bond above two stepped brick water table and English bond below. On the three visible sides is a belt course of three courses of brick. All of the sash have 2/2 panes but the frames appear original. In the gable is a string course. Two small casements flank each chimney. Both facades have a central door, but the south door is concealed from the exterior by the addition of a frame tower built on block foundations. On the west gable at ground level is a basement entrance and a single window. All of the windows have a plain rowlock arch.

In all likelihood, the building has the same plan as the Hassett Farm and the original Clay's Hope.

The wing is late 19th century and is covered with grey asphalt siding.

STATEMENT OF SIGNIFICANCE

The Plugge Farm is an important late 18th century structure probably constructed in the 1780's. It resembles Hassett Farm and Clay's Hope in form, fenestration and even basement entrance. The plans of each appear to have been identical originally. The additions are in no way an asset to the brick structure.


