DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two room, one story house was originally the service wing of a late Federal period house to the northwest. The side hall double parlor, two story house was torn down in the 1960's.

The remaining structure has a central chimney with back to back fireplaces. The southeast room has a 9/6 window on the north-east, a door on the southwest, and a door and 6/6 sash window on the southeast gable end. The northwest room has a door and 9/6 sash window on each of the southwest and northeast sides. A door on the northwest leads into a modern addition. A boxed stair stands in the west corner. The moldings throughout the house are simple flat boards, occasionally beaded.

In the finished attic the northwest room has a 6/6 sash window in each roof slope, while the southeast room has two 4-pane casement windows in the gable end.

There is an early barn on the property constructed of very large, roughly chamfered posts. The barn's many interesting construction features include a slightly tilted, thick rectangular false plate which is scarfed and pegged to connect sections.
