DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This small frame structure now stands on the east side of Hammond Street near Bay. Until it was moved in 1975 it was a rear addition to one of the so-called Langsdale House, Island House, (T-324), which stood at #122 North Washington Street until it was also moved to #218 Bay Street in 1975. The building faces west.

As it now stands "Little Brother" is three bays wide and two stories high. It is two bays deep with a one bay shed on the front. The second floor was added when the building was connected to the Island House, probably late in the nineteenth century. In its earliest form the house would have had one story plus an attic and a gable roof.

Early exterior details remain only on the front facade. There is a center entrance with frame trimmed with a bead and a quarter-round backband molding. The two windows which flank the door have identical trim. They once held six over six sashes and had louvered shutters. Only the bed mold of the box cornice remains. The weatherboard of the facade has a 5/8 inch bead; it is of random widths which probably average about seven inches. The detailing of this facade is quite bold.

The other weatherboarding, trim and roof coverings were likely added later, possibly after the building was attached to the house.

Inside, the house has one large room on the first floor and two rooms in the second floor addition.

The second floor is reached by an enclosed corner stair in the north east corner. The stair appears to be original to the earliest form of the building and is enclosed with vertical boarding. The stair door is board and batten and retains its HL hinges as does the small board and batten door to a cupboard under the stair. In the south east corner of the first floor room is a tiny kitchen; it appears to be a later addition built into the corner and reached by a narrow board and batten door.

In the rear of the building, opposite the entrance door is a window. Another first floor window is found in the western bay of the north wall. Two windows on the east wall of the second floor were added along with the second floor. When this structure was attached to the Island House a door was added in the present north wall.

Early pine flooring probably exists on both levels although it is presently covered with later flooring or with linoleum. Further study of this structure may reveal more early materials.

The building is in ruinous condition and threatened with demolition.


