DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Marvel House is an elegant three story mid 19th century frame building. Its basic plan is of a center hall with double parlors, each served by an end chimney, on either side. The second and third floors also have four heated rooms each with built in closets. At the south end of the hall there is a bathroom on the second floor and a large walk in closet on the third.

On the first floor, the western parlors are now one room. The slate mantels on their fireplaces are painted black with gold veining to simulate marble. The east mantels are wooden, with large rolled moldings. The stair has a squat, turned newel post. Most of the moldings feature a shallow ogee with many variations.

The shallow hipped roof extends over a dentiled cornice. A pilaster wraps around each corner. The house is covered in light green asphalt shingles. The one story porch with wrought iron posts which covers the south and half of the west side once continued around the west and north sides of the northwest parlor.

All the windows contain 6/6 sash, and the fenestration pattern on each floor consists of two windows between the chimneys on the west, a window between the chimneys and one to the north of the chimney on the east, two windows per parlor on the south, and two windows on the north side of the west parlor. The front door, to the south, has sidelights and a transom. The bath and closet above it are each lit by a 3/3 sash window. All the windows have louvered shutters.

A pantry and kitchen addition with bedrooms above and a back stair runs from the north end of the northeast parlor. The parlor has built in storage cupboards and counters, and the kitchen has a fireplace on the north. Both floors open onto a porch along the west side. A one story garage built in the 1930's extends to the north.

STATEMENT OF SIGNIFICANCE

The Marvel House is significant architecturally as an example of the great farmhouses of the mid-19th century constructed according to the two prevailing styles of the days of the Greek Revival and the Italianate. There are touches of both, although the corner pilasters and cornice belong to the Greek Revival while the squarish form is more Italianate. Its cast iron porch is a superior example of that craft which was popular more in Cecil and Kent Counties than in Talbot. The house has many features in common with Shorewood, Kent County.

Significant too is the fact that this was the home of Raymond Marvel, State Senator from Talbot County in 1939.



<p>This is a very plain box-like country structure which borrows it's basic design from the very elegant town houses of Baltimore or Boston. In this case the structure has been stripped of all sophistication and style and stands as a rather uncompromising box. It is 5 bays wide and 3 bays deep. All of the windows are 6/6, with the exception of the central windows on the second and third story, which have been altered. The central door has an overlight and sidelights. The roof is flat and has a projecting cornice with a row of dentils. There are thin pilasters at each corner of the building.</p> <p>A one story porch runs across the front and around one side of the house. It is of wrought iron and is possibly part of the original fabric of the structure.</p> <p>This house is interesting as an unusual type in this area rather than for any sophistication of design.</p>
