Oak Hill is a double house composed of two two-and-a-half story, three bay portions, now covered with shingles. Probably dating from the early nineteenth century, this frame structure was originally of the so-called "telescope" type; small wings, since moved, were situated at the east side of the present buildings. Once a simple farm house on the outskirts of Easton, the gable roofed structure is now used as apartments.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This large frame house stands on a triangular lot formed by the junction of North Washington Street and Glebe Road. It faces southeast. Once the grounds stretched to the junction of these streets; now the house is surrounded by small modern dwellings. The old name, Oak Hill, was given because the building stands on a rise of ground and is shaded by tall oak trees.

The structure now consists of two sections, each of which is frame, three bays wide and two stories plus an attic in height. Originally, the house consisted of four sections, the two two-and-a-half story portions plus two one-and-a-half story wings. Sometime before 1919 the two wings were moved nearly and are now used as private residences. Now a rented duplex, the sections were separated in 1940.

Most early woodwork and mantles of the western portion have been removed; pine floors have been covered with hardwood. The eastern portion has been more fortunate; there is a wall of raised and beveled paneling which appears to have been reassembled with a Federal type mantle added. There are at least three early six-panel doors with HL hinges remaining in use although they may not be in their original. A fragment of early chair rail and pine floors have also survived on the first floor.

The remaining two sections of the structure are covered with wooden shingles. Tall chimneys, covered with stucco rise at each end of the structure and between the two sections. The western chimney was rebuilt after a fire in the 1930's. Windows are situated one per bay on each floor on the front and rear of the building. Most original trim remains; it is beaded with a quarter round back band molding. Molded wooden sills project from the surface of the wall. Original sashes are six over six; however, most have been replaced with single or double Victorian sash. There are two small windows each gable end. In the west end they have four over two sashes; in the east end they have four lights. There are no dormers.

The two-story Colonial Revival porch on the western portion is a twentieth century addition. The weatherboarding was covered with shingles after 1919.

In both sections there is a central entrance. In the southeast portion a stair remains in its central, probably original position; the stair in the north west portion is modern.
